Of late, the consumption of Mineral water by the Otravelling public has been increasing. Taking advantage of this situation. the licensees of various Stalls/Canteens are selling Mater, eventhough they are not permitted to sell descriptions are being sought by some unit bricers on sale of Mineral Water by the Stalls/Canteens. licans

The issue of sale of Mineral Water by the licensees of Stalls/Canteens was also discussed during the Meeting of Executive Directors/Regional Managers/Heads of the Departments held on 19:502001. To asvoid litigation and complaints, a decision was taken that the licensees of various Stalis/Canteens should be permitted to sell. Mineral water at extra premium to the Corporation.

The following instructions are therefore issued for strict compliance:

- (1) Wherevers incences have been issued to any contractor for sale of Mineral Water on exclusive basis only such licensees shall be permitted to sell Mineral Water in such Bus Stations and permission to sell Mineral Water small not be given to any other licensee.
- 2) In all other places where no such exclusive licences have been given the Regional Tender Committee should meet and notify to the Micensees of Stalls/Canteens in all the Bus Stations under its jurisdiction that all the licensees shall be permitted to sell Mineral Water only after paying additional licence fee.

The additional licence fee shall be fixed by the Real Tender Committee based on the importance of the Bus Station.

4) Based on the recommendations of the Tender Committee and approval of the Executive Director concerned, the Regional Manager shall issue licences to the licensees of Stalis/Canteens who agree to pay the additional licence fee for the sale of Mineral Water. Those who do not agree to day the additional amount rowards the sale of the Mineral Water shall not be permitted to sell Mineral water.

 -----en will not change. In other words, the permission for
 sale of Mineral Water shall be co-terminus with the existing
 period of agreement.
- 6/ This condition shall be incorporated in the existing Agreement already entered into with the licensees of Stalls/Canteens.
