- 1. The Oil Companies have revised the HSD Oil rate upwards on 27.02.2010.
- 2. The Committee to review revision of hire rates payable to hire buses submitted its report recommending revision in hire rates payable to hire buses, consequent to upward revision in HSD Oil price on 27.02.2010. VC & MD accorded approval for implementation of the revised hire rates as recommended by the Committee.
- 3. The revised hire rates payable to hire buses w.e.f.27.02.2010 are as hereunder.

CATEGORY - 1:

The revised hire rates payable for Dist. Ordinary and City type hire buses of all models during the extended period of 3 years agreement (i.e. during agreement period of 6th year, 7th year and 8th year, with new bus body mounted), are as detailed in the Table below:

Further it is also instructed that before implementation of above hire rates, it shall invariably be ensured that whenever the hire rates are revised downwards, the amount that should be recovered are promptly recovered in the ensuing bills without fail and the amounts payable due to upward revision in hire rates being promptly paid as per the sanctions communicated.
