Government of Andhra Pradesh, vide G.O.Ms.No.30 dated 26-02-2011 of TR& B (TR.II) Dept., ordered that free bus pass facility be extended to Ex-MLAs.

Accordingly the following working instructions are hereby communicated to all unit officers for strict compliance.

- To allow all EX-MLAs hailing from Andhra Pradesh, travel by all types of buses of APSRTC on the strength of Identity Cards issued by the Legislature Department and this should be considered sufficient authority for travel.
- Attendants / Spouses of Ex-MLAs are not allowed to travel free of cost.
- The four seats reserved to MLAs, their spouses/attendants and MPs be allotted to Ex-MLAs on first preferential basis in the event of the Hon'ble MLAs/MLCs, their spouses/attendants and MPs do not turn up.
- The other terms and conditions governing travel concessions to MLAs/MLCs and MPs hailing from Andhra Pradesh shall also apply in case of Ex-MLAs.

- The journey particulars of Ex-MLAs shall be recorded by the operating staff in the SR of the service concerned (in case of TIM necessary entries be recorded) and at the depot level the actual cost of travel shall be arrived month-wise which shall be submitted to the Regional Manager concerned. The RM in turn shall arrange to consolidate the data along with other free / concessional bus passes and to send the Regional monthly periodical to Corporate Office.
