  6. Hire rates review Committee's recommendation for revision in hire rates payable to all category & types of hire vehicles due to revision in HSD oil price during 01-04-2005 to 21-06-2005 and approval of VC & MD for implementation of the recommendations.

1. The Oil companies have revised the HSD Oil rate upwards on 01-04-2004, downwards on 08-04-2005 and upwards on 21-06-2005.
2. As recommended by the Committee, VC & MD has approved the revised hire rates payable per kilometer to all following 4 category of hire buses under operation.
3. The revised hire rates for implementation are as detailed below.
