Sub: BUS PASSES - Issue of concessional bus passes to the students studying in private un-aided Junior Colleges. - Instructions issued - Reg.

Attention is invited to this Office letter and cited through which a copy of the G.O. Ms.No.60, dt.28-03-2000 was forwarded to all the Regional Managers requesting them to note the contents of the G.O. and to take appropriate action in the matter.

Government of Andhra Pradesh vide G.O. cited above communicated that keeping in view the judgements of Hon'ble High Court of Andhra Pradesh in W.P.No.13941/99 and 14070/99 and also in similar other cases, the conditions imposed earlier are withdrawn. It is further ordered that the Commissioner and Secretary, Board of Intermediate Education, A.P. may accord permission for starting of new private un-aided Jr.Colleges/Courses, as per the conditions prevailed prior to 25-07-95.

The following are the conditions withdrawn vide G.O.1st cited.

- . Corpus fund should be deposited as per the Rules in force.
- . No grant-in-aid will be paid now or in future.
- . No scholarship will be given to the students enrolled in these institutions courses of study.
- . No concessional bus passes will be given to the students enrolled in these institutions / courses of study.

But, clarifications are still sought by some of the Unit Managers besides receipt of numerous representations from the Heads/Principals of Jr.Colleges in regard to issue of concessional bus passes to the students studying in private un-aided Junior Colleges.

The matter has been therefore re-examined and it is decided to issue concessional bus passes to the students studying in private un-aided Junior Colleges / Courses including those students studying in co-operative colleges subject to fulfilling all the other requisite conditions prescribed for issue of bus passes to the student category.

All the Regional Managers / Depot Managers are therefore advised to take action in the matter accordingly.
