Sub: **HIRING** - Hiring of private buses - Revised hire rates payable to hire buses w.e.f. 05.06.2008 consequent to revision in HSD Oil price on 05.06.2008 - Reg.

1. The Oil Companies have revised the HSD Oil rate upwards on 05.06.2008.
2. The Committee to review revision of hire rates payable to hire buses submitted its report recommending revision in hire rates payable to hire buses due to revision in HSD Oil price on 05.06.2008. VC & MD accorded approval for implementation of the revised hire rates as recommended by the above Committee.
3. The revised hire rates payable to hire buses w.e.f. 05.06.2008 are as detailed below.

**Category - 1**

The revised hire rates payable w.e.f. 05.06.2008 for all types of hire buses of 2003 model introduced in pursuance of Notification of hiring of private buses issued on 01.03.2003; and for all types of hire buses of 2003 or 2004 models supplied from February, 2003 onwards as replacements to old model hire buses, are as detailed below.

**Category - 3** (i.e FOR HIRE BUSES INTRODUCED UNDER "QUOTATION BASIS").

- I. The existing hire rates to be increased by w.e.f. 05.06.2008 in respect of all Mini hire buses engaged on quotation basis in pursuance of hire Tender Notification issued on 09.01.2004 and in all hire Tender Notifications issued subsequently, is as detailed below.

1	MINI ORDINARY	44 Paise per Km.
2	MINI CITY	47 Paise per Km.

- II. The existing agreed hire rates to be increased by, w.e.f. 05.06.2008 is as indicated in the Table below, in respect of all big hire buses engaged on quotation basis in pursuance of all Hire Tender Notifications issued on 09.03.2004 and in all Notifications issued subsequently; and also for all hire buses of 2007 or later models supplied as replacements to old model hire buses.

4. The revised hire rates shall be endorsed in the agreements entered into by way of issue of an amendment duly acknowledged by the hire bus owners.
5. The payment of hire charges bills shall be pre-audited.
6. Insurance paid on the vehicle has to be reimbursed on proportionate basis.
7. Further, it is also instructed that, before implementation of above hire rates, it shall invariably be ensured that the instructions issued vide circular in reference 2<sup>nd</sup> cited are complied with i.e., whenever the hire rates are revised downwards, the amount that should be recovered are promptly recovered in the ensuing bills and the amounts payable due to upward revision in hire rates being promptly paid.
