SUB : POSTAL MAILS - Carriage of Postal Mail Bags in our Buses - Claiming and realisation of subsidy from Postal Department - Conducting of joint weighment twice, for a period of 2 weeks each in the months of April 1999 and October 1999 - Instructions - Regarding.

Comprehensive guidelines in conducting joint weighment, calculation of Postal Subsidy amount, raising of bills and realisation of amount from Postal Department towards Carriage of Postal Mail bags in our buses were issued through the Circulars cited.

Previously, joint weighment of Postal Mails was conducted twice for a period of 2 weeks each in the months of June, 1998 and October, 1998 and the average weight thus arrived at is valid from 1-4-1997 to 31-3-2000.

As the period of validity of the joint weighment conducted in the year 1998 comes to an end by 31-3-2000, it is decided to undertake joint weighment of Postal Mail bags carried in our buses, twice for a period of 2 weeks each in the month of April, 1999 from 15.04.99 to 30.04.99 and in the month of October, 1999 from 04.10.99 to 16.10.99.

Vide reference cited under 9, the Chief Post Master General has issued instructions to all the concerned Postal authorities to co-operate in the joint weighment of Postal Mail Bags during the above said period.

All the Regional Managers are therefore requested to arrange to conduct joint weighment of Postal Mail Bags transported in our buses on all routes for a period of 2 weeks each in the month of April 1999 from 19.04.1999 to 30.04.1999 and in the month of October 1999 from 04.10.1999 to 14.10.1999. The average weight thus arrived at should be made applicable from 01.04.2000 to 31.03.2003.

The Regional Managers shall designate responsible Traffic Supervisors to carry out joint weighment of Postal Mail bags on all routes correctly during the period of weighments on the above dates.

After completion of joint weighment of Postal Mail Bags on the above dates, the average weight of Postal Mail Bags Carried in our Buses on all routes shall be furnished by the Depot Managers in the proforma annexed to Circular 8th cited to Dy. Chief Accounts Officer/ Accounts Officer of the Region who in turn shall raise the revised bills w.e.f. 01.04.2000 as per the calculations communicated vide Circular 7th cited.
