Several representations are being received from the Heads of some of the Colleges / University Colleges, Institutions running Vocational, "Add on" Courses, students undertaking Projects / research works - M.Phil, Ph.D, M.B.A., M.C.A etc., requesting to issue concessional bus passes to the students studying the said courses, extending into summer vacation i.e. April to June, on the ground that these courses are run with the permission of the Government of A.P.

Corporation has requested the Prl Secretary to Government, TR&B Dept, vide letter 2nd cited to issue a directive whether to extend the concessional bus passes facility to the students undergoing training in various "Add on" courses during the months of April, May and June so as to enable to include the claim on bus passes to students for 100% reimbursement by the Govt. of A.P. and in terms of G.O.Ms.No.35, Dated 16.03.2002, Government approval is required to extend any new concessions to any category of commuters.

Government vide letter 1st cited (copy enclosed) directed the Corporation not to extend the concessional bus pass facility to the students studying Vocational, "Add on" Courses, research scholars undertaking project works etc. during summer vacations.

All the Regional Managers are therefore advised not to issue / renew the concessional bus passes to the students undergoing training in various "Add on" Courses etc., students undertaking Projects / research works - M.Phil, Ph.D, M.B.A., M.C.A etc., during the months of April, May and June i.e. after completion of their Academic courses based on the representations received from the Heads of the Colleges / University Colleges, Institutions
