Tenders were called for installation of Kiosks for
provision and sale of safe drinking water in Bus Stations of
the Corporation.

The Tender Committee, constituted by Vice-Chairman &
Managing Director has opened the Tenders on 15.5.2001, held
negotiations with the highest tenderers on 26.5.2001, and
recommended for allotment of 6' X 6' space in the following
Bus Stations for installation of KIOSKS.

The licence period of the Kiosks is 3 years only.

The Regional Managers shall collect Security Deposit equivalent to six months licence fee, as shown above, and one month's advance licence fee from the successful tenderers, and enter into an agreement before 25.6.2001.

A draft copy of the agreement to be entered into with the successful tenderer is enclosed here with.

The agreement has to be signed by the Regional Manager only. No other person on behalf of Regional Manager is authorised to sign the agreement.

The Regional Managers shall issue instructions to the concerned Depot Managers and ensure allotment of 6' X 6' space in the above Bus Stations for installation of Kiosks. As far as possible, the space to be allotted for the installation of Kiosks shall be conspicuous/prominent. However, care shall be taken that on account of the location of the Kiosk, there shall not be obstruction for free movement of the public in the Bus Stations.

The monthly licence fee shall be collected from the date of entering into agreement.

The monthly licence fee is exclusive of electricity and water charges.

The Regional Managers are advised to ensure exhibition of required Certificate in the Kiosks by the licensees, as per clause 9 of the agreement. The water shall be sold in the Kiosk only. Under no circumstances, the licensee shall be allowed to sell the water through hawkers.

The Regional Managers should inspect the Kiosks frequently and if any licensee is found violating any conditions of the agreement, action shall be taken against the licensees in terms of clause Nos. 14 and 15 of the agreement.
