CIRCULAR NO.28/99-OPD(C):DATED:17-5-1999.

Sub:ELECTRICITY CHARGES: Collection of Electricity Charges from Advertising Agents, ANL Parcel Service, Person Weighing Machines, licensees of Canteens, Stalls/ Shops etc. + Communication of Revised Tariffs - Regarding.

Instructions were issued vide Circulars cited on collection of electricity charges from licensees of Canteens, Stalls/Shops etc. Advertising Agents, ANL Parcel Service, Person Weighing Machines.

The latest APSEB tariffs (revised) which came into force with effect from 1st January, 1999 have been communicated to all Officers of Corporation through Circular No.4/99-MED:Dated:2nd February, 1999.

In view of the revision of tariff by APSEB, revised electricity charges are to be collected from (a) Advertising Agents (Immobile Media and CCTV) (b) ANL Parcel Service (where accommodation is provided to them) (c) Agents of Person Weighing Machines (d) Licensees of Canteens, Stalls/ Shops, Office accommodation (provided in our Bus Stations and Commercial Complexes) etc. at the rates specified below:

FOR ADVERTISING AGENTS (IMMOBILE MEDIA AND CCTV),
ANL PARCEL SERVICE, LICENSEES OF CANTEENS, STALLS/
SHOPS, OFFICE ACCOMMODATION ETC.

- 1) Where Power is supplied through a separate meter Total amount as per the bill received from the electricity Board.
- 2) Where Power is supplied through a sub-meter;
- i) Rs.4.95 per unit + 06 paise per unit. (towards duty charges) for all units consumed.
 - ii) MONTHLY MINIMUM CHARGES:
 - 1) Rs.65/- per month for single phase supply.
 - 2) Rs.200/- per month for three phase supply.
- 3) Where Sub-meter is not fixed or not working.
- The Electricity charges shall be collected in consultation with Dy.Engineer(Electrical) concerned, subject to a minimum of ..
- 1) Rs.65/- per month per point for single phase.
 - 2) Rs.200/- per month for three phase supply.

FOR PERSON WEIGHING MACHINES:

- a) Where Sub-meter is fixed.
- Rs.4.95 per Unit + 06 paise per unit. (towards duty charges) for all the Units consumed.
- b) Where Sub-meter is not fixed or not working.
- The Electricity charges shall be fixed in consultation with Dy.Engineer (Electrical)concerned subject to a minimum of Rs.200/- per machine per month.

The above rates are applicable in respect of the Bus Stations coming under the purview of L.T. Category-II, i.e., NON-DOMESTIC AND COMMERCIAL - SUCH AS OFFICES, STALLS ETC.

In respect of the Bus Stations falling under H.T. category, electricity charges have to be collected as per the rates applicable to H.T. Category as detailed in the circular 6th cited, in consultation with Dy. Executive Engineer (Electrical) concerned.

Installation of sub-meters duly tested by ARSER shall be insisted wherever sub-meters are not yet provided, for correct assessment and realisation of Electricity Charges.

The sub-meters of all the Stalls/ Shops, Canteens, etc. should be installed at one place preferably in a room provided with lock and key. The key of the Room shall be with the Bus Station Manager. In case of doubt / dispute over wrong functioning or non-functioning of the sub-meter, Dy. Engineer (Electrical) shall be contacted for correct assessment. In case of Stalls where sub-meters are not fixed, Dy. Executive Engineer (Electrical) shall invariably be contacted for correct assessment of Electricity Charges.


The revised rates are applicable w.e.f. 01-01-1999.

All the Unit Officers are advised to collect the electricity charges at the revised rates regularly, without giving scope for accumulation of dues towards Electricity Charges.

The licensees / Advertising Agents / Parcel Service Agents shall not be allowed to use Electrical Heaters, Electrical Stoves and other heavy electrical appliances in our premises.

The Regional Managers shall ensure that Electrical Charges are being assessed and realised in full from the Advertising Agents, Company / Firm of Weighing Machines and Contractors of Stalls / Shops, Canteens, etc. basing on the actual consumption of Electricity.
