Sub:- BUS STATIONS:- To call for the tenders at Regional level for allotment of Stalls/Spaces at the Bus stations to sell Reverse Osmosis(R.O) treated water at nominal rates - Issue of instructions - Reg.

Stalls/Spaces in the Bus stations are presently licensed out for sale of pure and safe drinking water to the passengers through Water Stalls/Kiosks. The licensees are permitted to sell packaged drinking water bottles of reputed brands at MRP rates in water stalls.

The licensees of water kiosks are however permitted to sell loose water (in the form of sachets/refilling) with BIS standards to the passengers at reasonable rates specified by the corporation.

In view of increasing demand for pure and safe drinking water at the Bus stations, it is now proposed to allot stalls/space at Bus stations for selling R.O treated water to the passengers at the rates as specified by the corporation. The VC & MD therefore directed with the concurrence of FA as follows.

1. To call tenders for allotment of Stalls/Spaces at all Bus stations for selling R.O treated water (except the following Bus stations where already R.O.Water Plants are installed by the Donar Agencies/ Public Representatives at free of cost).

2. The contract shall be allotted on the basis of highest monthly licence fee offered by the licensee.

3. The licensee will be permitted to sell loose water(R.O treated) in sachets, refilling in bottles and pet bottles to the passengers at the following rates.

SNO	Quantity of water	Rate Rs.
1	250 ml. sachet	1/-
2	1 ltr bottle refilling	2/-
3	2 ltr bottle refilling	3/-
4	1 ltr with pet bottle	4/-

4. Tenders shall be called for allotment of stalls/spaces to sell R.O.water at all the Bus stations under usage, irrespective of no.of water stalls/kiosks available at the Bus stations.
5. The RM is the competent authority to finalize the tenders basing on the recommendations of the Regional Tender Committee.
6. The licence period of stalls/spaces for selling R.O.water is 5 years.
7. The licensee shall sell safe drinking water as per the Bureau of Indian Standards by obtaining a certificate from BIS(As per the standards enclosed at ANNEXURE).
8. The licensee shall exhibit a Certificate Issued by BIS in the kiosks, at a prominent place for clear visibility to the traveling public.
9. The licensee shall maintain the water kiosk in clean and hygienic environment.
- 10.The licensee shall not use harmful Chemicals in the process of purification of water.
- 11.The samples of water sold in the Sachets/Bottles shall be sent fortnightly(i.e. twice in a month) on random basis for biological and chemical analysis to the Authorized Government Testing Laboratories by the concerned Depot Manager/Asst.Traffic Manager, towards which RTC will bear the charges.
- 12.a) If the sample water sent for testing is found unfit as per to that of BIS standards, the penalty upto a max. of Rs.1,000/- can be imposed based upon the no.of times the water didn't meet the standards on each occasion irrespective of the type of Bus station.
- b) If the sample water sent for testing is found to be unfit as per BIS standards for more than six times in a calendar year, the licence will be terminated with one month advance notice.

13. The tender committee will fix the most appropriate place both to the convenience of the passengers and as well as to the corporation. If it is proposed to allot open space, the Regional Tender Committee along with CBD shall finalise the space and enclose its drawing along with the tender schedule.

The regional Managers are therefore requested to call for tenders immediately and finalise the contracts before 28.02.11 without fail and report compliance.
