**CIRCULAR NO.30/2007-OPD-C, Dt.20.8.2007.**

**Sub:- COMPENSATION** – Payment of compensation to the victims of accident involving APSRTC buses – Enhancement of expenses towards treatment, incidental expenses to the injured passengers and funeral expenses to the deceased – Regarding.

Corporation has been paying compensation to the victims and dependents of the deceased in accidents involving APSRTC vehicles. Funeral expenses are being paid to the heirs of the deceased and also certain expenses are being paid to the injured passengers for the treatment.

At present an amount of Rs.1,000/- is being paid to the family members of the passengers and other road users died in the accidents involving APSRTC buses towards funeral expenses. This amount was fixed long back and no revision has been made in the amount, though the cost of material required for funeral and incidental expenses to the injured passengers during the treatment period have increased multifold.

It is therefore felt that there is a need to enhance funeral expenses and incidental expenses being paid to the injured passengers.

Also, in terms of M.V.Act (Amendment) 1994, Section. 163-A, under Second Schedule, the funeral expenses to be paid to the family members of deceased is Rs.2,000/-.

The Corporation has decided to enhance the funeral expenses and also the expenses being paid to the injured passengers towards treatment vide Resolution No.83/2007, Dt.4.8.2007.

Accordingly, the amount for the funeral expenses has been enhanced from Rs.1,000/- to Rs.2,000/-.

At present, no amount is being paid to meet the expenditure incurred by the attendants of the passengers injured in road accidents involving APSRTC vehicles and taking treatment at the hospitals.

Keeping in view the incidental expenses to be incurred by the attendants of the injured passengers during the treatment period, it is decided to enhance the amount being paid towards the expenses incurred by the injured passengers.

The expenses presently being paid to the injured passengers towards treatment as per the delegation of powers 'Operational (Traffic) Matters' Section-3, item No.9, and revised amounts are furnished hereunder:

Temporary disablement of a passenger or other road user

Sl. No.	Nature of powers	Powers Delegated to	Existing	Revised
(i)	If treated as inpatient for a period upto three days.	RM	Rs.200/-	Rs.600/-
(ii)	If treated as inpatient for more than three days	RM	Rs.250/- per week subject to a maximum of Rs.5,000/-	Rs.700/- per week subject to a maximum of Rs.10,000/-
(iii)	If disabled from resuming duty or work and treated as an out patient	RM	Rs.100/- per week subject to a maximum of Rs.3,000/-	Rs.300/- per week subject to a maximum of Rs.6,000/-

The other conditions / guidelines communicated vide Circular No.47/96-OPD©, Dt.29.7.1996 and 21/2007-OPD©, Dt.9.5.2007 stand good.
