## CIRCULAR NO. 30/2008-OPD(P), DT21.08.2008.

Sub: **FARES** - Charging of 1.50 times of the normal fares for all special type services viz. Express/Deluxe/Super Luxury/Volvo and above type services (other than schedule services) to be operated including inter-State routes to clear additional traffic during special occasions - Instructions issued - Reg.

Corporate Office has issued instructions Vide Circular 2<sup>nd</sup> cited, to operate additional services during special occasions like fairs and festivals, holidays, weekends, long vacations, jatharas etc., @ 1.3 times the normal fare for Express and Deluxe services and 1.5 times the normal fare for Super Luxury and above type services.

The Board vide Resolution 3<sup>rd</sup> cited has resolved to **charge 1.5 times of the normal fare uniformly for all special type services other than schedule services operated to clear additional traffic on special occasions as indicated above.**

All the Regional Managers are therefore advised to charge 1.5 times of the normal fare uniformly for all special type services viz. Express, Deluxe, Super Luxury, Volvo and all other high end buses during special occasions like fairs and festivals, weekends, long vacations, jatharas and on any occasion where there is a need to operate additional services / buses over and above the schedule services / buses to clear additional traffic to tide over the exigencies since permitted by Govt., vide G.O.Ms.No.16, TR&B (Tr.II) Dept., dt.03.02.2003.

However, charging of normal fare for the scheduled special type services operating on any route will continue. The scheduled special type services operating on the routes should not be cancelled under any circumstances wherever additional special services are operated. An exclusive board as "SPECIAL SERVICE" with special service number near the destination board shall be displayed for the information of the traveling public and to avoid criticism.

These instructions will come into force with immediate effect.
