SUB:CANCELLATION/REFUND; PRE-PONEMENT/POST PONEMENT RULES:- Modification of Cancellation/Refund, Pre-Post-ponement of journey rules to make them more passenger-friendly-instructions issued-Regarding.

- I. APSRTC has introduced the facility of advance reservation of tickets, to facilitate the passengers intending to travel by the long distance / inter state services to plan their journey and book seats. This facility, while ensuring a seat to the passenger, enables the organisation to realise the ticket amount in advance as well as to assess and meet the demand. At the same time, the facility of cancellation / pre-ponement and post-ponement of reserved ticket is also extended to meet the varied demands of our customers and arrange refund of fare duly deducting certain amount for such facility.
- II. The rules of cancellation, pre-ponement/post-ponement of journey and procedure of refund were communicated through the circular cited.
- III. After five years, the cancellation, pre-ponement/post-ponement rules are reviewed once again and decided that they deserve to be modified to make them more simple and passenger-friendly.
- IV. Modified rules are notified overleaf the circular.
- V. These modified rules come into effect from 1.9.2001.
- VI. The Unit Officers are advised to circulate these modified rules to all the Supervisors, Staff working in bus station counters and Authorised Ticket Booking Agents for effective implementation. They are also advised to undertake publicity of these passenger-friendly modifications through display on notice boards at conspicuous places at all our bus depots/bus stations/agents counters so as to make these modified rules known to the passengers.
