The Corporation is presently issuing two types of Monthly General Bus Tickets i.e., G B T (City/Suburban) and G B T (Metro Express) to the State Government employees (hither to referred as NGOs of A.P. State Govt.) working in twin cities, Vijayawada, Visakhapatnam and Warangal. The cost of the pass is shared in the ratio of 1:2 between the NGO and the A.P. State Govt. as detailed below.

- to continue the present concessional bus pass facility to the employees of the State Government who are working in Twin Cities of Hyderabad and Secunderabad, Visakhapatnam, Vijayawada and Hanmakonda / Warangal / Kazipet and who are drawing the pay in the scales below the scale of Rs.14860-39540 (Revised Pay Scales, 2010), irrespective of their status either Gazetted or Non-Gazetted,
- to extend of the above facility to the Government employees who are working in the limits of all the Municipal Corporations in the State also; if the APSRTC is running City services at those places and and applications of shipping as (viewiosqueri
- the Government employees to travel by Metro Liners and A/c buses also, subject to the condition that the share of Government should not exceed 2/3rd cost of travel by Ordinary buses and the remaining cost to be borne by the concerned Government employee.

The Government directed the Corporation in the G.O. cited to implement the said facility and to take action in the matter accordingly. After examining the issue in detail, the following instructions are therefore issued to all the Regional Managers for compliance.

1) Apart from the existing two types of General Bus Tickets (Monthly) to the State Government employees priced at Rs.170/- and Rs.270/- which are valid in Ordinary and Metro Express services, third type of pass is made available to the employees willing to avail Metro Deluxe Monthly General Bus Ticket, wherever Metro Deluxe services are under operation @ Rs.370/-(Rupees Three hundred and Seventy only) with Government share of Rs.330/- to each of the above ticket. Accordingly the existing types of Monthly General Bus Tickets to the State Government employees (hither to referred as NGOs of A.P. State Govt.) are reproduced hereunder.

- 2) The present concessional bus ticket facility to the employees of the State Government who are drawing the pay in the scales below the scale of Rs.14860-39540 (Revised Pay Scales, 2010) irrespective of their status either Gazetted or Non-Gazetted be issued.
- 3) Holders of these Monthly GBTs are allowed to perform journeys by Ordinary as well as Metro Express/Metro Deluxe services in respective cities, if APSRTC city services are under operation.
- 4) Prior permission from the Corporate Office has to be obtained whenever this facility is extended to other Municipal Corporations. (Apart from twin cities of Hyderabad & Secunderabad, Vijayawada, Visakhapatnam and Warangal with details of such services to which this facility is applicable for State Government employees).
- 5) The Dy.CAO of the Region concerned shall prefer claim for payment of its share of Rs.330.00 per ticket as in the case of other types of bus passes.
- 6) As and when the tariff of GBTs is hiked, the Government of A.P. will continue to pay its share in the ratio of 1:2 (between the employee and the Government respectively) as applicable for Ordinary Monthly General Bus Ticket only, while the difference cost has to be borne by the employee willing to avail higher class bus passes.

- 7) As on date no GBT is available for General Commuters in AC services. Separate communication will be given for extending facility in AC services as and when GBTs in AC services are introduced.
- 8) The Office Specials shall not be operated with the buses of Metro category.
- 9) All other existing terms and conditions applicable for issuing monthly bus tickets hold good to the State Government Employees willing to avail Metro Deluxe services.

These instructions shall come into force with immediate effect.
