- v) The Corporation shall pay fines, compounding fee etc., imposed by a Court, RTA or STA against the permit holder u/s 86 of M.V.Act for contravention of any provision of Law provided that such contravention or violation has occurred when the vehicle has plied for the Corporation.
7. i) The owner shall provide a driver/drivers with a valid driving license having validity of not less than 5 (Five) years experience to drive HPMV/HGV or "TRANSPORT VEHICLE" and P.S. Badge for the vehicle supplied by him, who shall follow the instructions of the authorized Officials of the Corporation.
- ii) It is agreed that in case of major accident, the driver involved in the accident shall be withdrawn by the owner immediately and the owner shall provide another driver / drivers as replacement. The drivers withdrawn on account of involving fatal / major accident shall not be re-engaged or appointed by the owner.
- iii) It is agreed that in case the driver of the vehicle is found disobedient or discourteous towards passengers, the owner shall replace the driver within 24 hours of the request of the Corporation for his replacement.
- iv) The owner shall not employ the following category of persons as drivers for operating the buses on hire basis.
- a) A person who has been removed or dismissed from the Corporation.
 - b) A person who had retired from the service of the Corporation either on attainment of the age of superannuation or any other ground.
 - c) A person who is aged more than 58 years.
 - d) A person who was working on any other hired bus and who was replaced by the owner of that bus either by the owner himself or on a complaint made by the Corporation against that driver for his replacement for any irregularity.
- v) It is mutually agreed that the driver employed by the owner shall undergo medical examination by a Medical Officer of the Corporation and he will be permitted to ply the vehicle only when the Medical Officer certifies that he is fit for the job of a driver.
- vi) It is agreed that the change of employment of driver should be intimated in advance to the concerned Depot Manager.
- vii) The owner shall furnish a Photostat copy of the Driving license and date of birth certificate of the driver to the concerned Depot Manager.
- viii) The Corporation shall provide a conductor for the operation of service with necessary equipment for issuing tickets to the passengers as well as luggage.
