Sub: **B**US **P**ASSES – Bharat Scouts & Guides, A.P. – Celebration of 16<sup>th</sup> National Jamboree 2011 – Conducting training camp at Shankarpalli, Ranga Reddy District, Hyderabad from 20<sup>th</sup> December 2010 to 15<sup>th</sup> January 2011 – Extension of 50% concession in fares to the participants by the buses of the Corporation – Instructions issued – Reg.

The State Chief Commissioner, Bharat Scouts & Guides, A.P. through the letter cited has informed that the Bharat Scouts and Guides, National Head Quarters New Delhi is organizing 16<sup>th</sup> National Jamboree at Shankarpalli, Ranga Reddy District, Hyderabad from 20<sup>th</sup> December 2010 to 15<sup>th</sup> January 2011, wherein around 2,600 Scouts & Guides including Adult Leaders from all Districts in A.P. are expected to participate in the said Jamboree and requested to extend 50% concession in fares to the participants to travel by the buses of the Corporation from 20<sup>th</sup> December 2010 to 15<sup>th</sup> January 2011.

VC & MD has ordered to extend 50% concession on normal fares to the Scouts and Guides participating in the Jamboree for travel in APSRTC services both in Up and Down journey within Andhra Pradesh State.

The Asst. State Secretary (Scouts) will sign the concession form as was being done earlier and forward the same to the various districts for counter signature by District Commissioner of the District concerned, who in turn will issue two concessional certificates to the participants. The two certificates are, one for UP and the other for RETURN journey. The validity of the certificates shall be from 20<sup>th</sup> December 2010 to 15<sup>th</sup> January 2011.

The Conductor of the bus on collection of the concessional certificates shall issue normal tickets for the journey duly collecting half the normal fares. The ticket numbers, thus issued carefully be entered on the concessional certificates which would be handed over to the Asst. Depot Clerk along with the way bill after the spell of duty. The Depot Clerk / Asst. Depot Clerk after certification should forward the concessional certificate as voucher to the Dy.Supdt. (F) of the Depot who will credit for the money less collected from the Scouts and Guides as per the entries made in the concession certificates.

The way bills and relevant vouchers should be submitted to the Dy.CAO of the Region for scrutiny and after receipt of the credit letter, the deficiency should be cleared by the Depot.

All the Depot Managers are, therefore, advised to take necessary action as indicated above.
