I. Consequent to fare hike with effect from 6.10.2000, the tariff of JET tickets (both Express and Hi-Tech) are revised. The revised tariff is given below :

II. The sale of 10 days JET tickets has been dispensed with due to poor response.

III. The collection of refundable deposit i.e. Rs.50/- on Adult Ticket and Rs.25/- on Child Ticket and other terms & conditions stipulated in the earlier circulars/letters stand good.

IV. The revised tariff will come into force with effect from 01.11.2000.

V. The sale of 10 days Jubilee Express and Jubilee Hi-Tech Tickets shall be stopped by 31.10.2000. However, the journey for the period of 10 days on the tickets sold shall be allowed upto 10 days from the date of issue.

VI. The stock of existing 7 days JET (Express and Hitech) shall be utilised by over stamping with revised tariff. The stock of 10 days JET (Express & Hitech) shall not be utilised beyond 31.10.2000 and left over stock has to be burnt duly following duly following the procedure in vogue.
