The Commissioner of Family Welfare, Govt. of Andhra Pradesh vide letter 1st cited has informed that the "Pulse Polic Immunisation Programme" will be implemented in two phases on 10-12-2000 and on 21-1-2001, in addition to house to house visits by the immunisation teams to ensure that not even a single child is left un-immunised with polic drops. He has therefore requested APSRTC to extend cooperation as was done on the previous campaigns.

As a part of participation by APSRTC, the following instructions are issued to all the Regional Managers/Depot Managers for successful implementation of the programme.

- 1) The authorities of Family Welfare Department, Govt. of AP be permitted to fix Pulse Polio Immunisation Posters and messages inside the buses and bus stations and on bus panels, free of cost, in the 10% quota reserved for APSRIC.
- 2) Publicity posters of the campaign be allowed to be affixed with cello tape inside the buses.
- 3) The crew of the buses shall be instructed to give priority to the parents of the children taking them to the PPI posts while boarding the buses on payment of normal fares. However, the children in the age group of 0-5 years will not be charged any fares as usual.
- 4) Co-operation shall be extended to the District Administration in organising the PPI Posts in the bus stations on the crucial dates.

5) Buses may be provided to the District Administration or the Medical and Health Department Officials if requisitioned,, on normal special hire basis for transportation of staff and material connected to pulse polio Immunisation during the days of the programme.

All the RMs/LMs are therefore advised to adhere to the above instructions for successful implementation of the programme.
