Sub:**HIRING**: **Hi**ring of private buses – Tyres Cost-Payment of variance in cost of Tyres due to escalation in the cost Tyres – Recommendation of Committee to pay 2 Ps. per Km. to all hire buses – Instructions for payment of 2 Ps. per Km by way of adding it to prevailing hire rate - Reg.

It is to inform that provision is made in the Hire Tender Notifications issued in the months of March, May, June, July (issued in HCZ only), August, October and December 2007 for revision (increase / decrease) of the hire rates in line with revision in price (increase / decrease) of tyres and wages of drivers and cleaners. However, the periodicity of review of tyres cost is once in a year and for that of wages cost will be once in two years.

A Committee is constituted to review the need for revision (increase / decrease) of the hire rates to hire buses of above Notifications in line with revision in cost (increase / decrease) of tyres. The Committee having reviewed this issue recommended for payment 2 (Two) Paise per Km. towards difference of cost of tyres to all types of hire buses introduced in pursuance of the said Tender Notifications.

VC&MD with the concurrence of F.A. approved the above recommendation of the Committee and ordered for implementation.

Therefore following instructions are issued for implementation.

1. All types of hire buses which were introduced in pursuance of hire Tender Notifications issued in the months of March, May, June, July (issued in HCZ only), August, October and December 2007; and all types of hire buses which were supplied as replacements to old model hire buses in pursuance of the offer extended to owners of hire buses in the year 2007, are entitled to be paid the difference in escalation of cost in tyres.

- 2. The rate payable to the said hire buses towards difference in escalation of cost of tyres, is 2 (Two) Paise per Km_for operated KMs_and payable with effect from 1st March 2008. The prevailing hire rate payable per Km. of the said hire buses shall be increased by 2 (Two) Paise per Km. and continue to pay the revised hire rates.
- 3. In case any hire bus of the said Tender Notifications was introduced after 1st March 2008, the prevailing hire rate payable per Km of such hire bus shall be increased by 2 (Two) Paise per Km from the date of its commencement of operation and continue to pay the revised hire rates.
- 4. The arrears of difference cost of tyres payable to above said hire buses shall be worked out for the operated Kms. and shall be paid on pre-audit basis. In case hire buses of the said Tender Notifications which were introduced after 1st March 2008, the arrears shall be calculated from the date commencement of operation and shall be paid.
