## CIRCULAR NO. 04/2011-OPD(T), DATED 16.02.2011

Sub:-<u>OPERATIONS</u> - Non-Cooperation Call given by Telangana JAC w.e.f. 17.02.2011 - Certain guidelines issued - Reg. -oOo-

You are aware that the Telangana Joint Action Committee has given a call to all State & Central Government Employees to observe 'Non Co-operation' with the Government on the issue of separate Statehood to Telangana w.e.f.17.02.2011.

During the Non Cooperation Movement, there is a possibility that our employees may also join and the passengers may not take the tickets for the travel. In this connection, it is to inform that being an essential public transport organization, and keeping in view of present financial constraint being faced by the Organization, there is a need to stay away from the call given by T.JAC to ensure non-participation of our employees in the Non Cooperation Movement. The issue shall be tackled sensitively by educating both our staff and agitators duly appraising the present status of Organization. Your active role in this regard is very much necessitated to over come the situation.

You are advised to conduct an emergency meeting with all Union personnel immediately and take their cooperation to educate our employees not to participate in the agitation initially. Further, you should appraise the loss of around Rs.188.00 Crores incurred to APSRTC on account of various agitations, the present loss of around Rs.200.00 Crores till December-2010 which is likely to touch around Rs.350.00 Crores by the end of this financial year.

Further, losses have also been reported enormously due to revision of Pay Scales to all employees. If our employees participate in the ensuing Non Cooperation Agitation, no doubt the losses will further mount up which is detrimental to the interests and very existence of the Organization.

In this connection, the following guidelines are issued for strict adherence.

- 1. Regional Managers shall be in contact with the District Collectors & SPs and Dy.CTMs/DMs shall be in contact with the local police for smooth operation of buses.
- 2. The police authorities shall be requested to provide adequate police bundobust at Bus Depots and Bus Stations to avoid any untoward incident.
- 3. RM's Office shall establish a communication cell and inform the hour-wise status to the Communication Cell of Corporate Office, jointly organized by Traffic & Vigilance Departments, from 04.00 Hrs of 17.02.2011 till the proposed Non Cooperation Agitation called off. A responsible supervisor shall man the Regional Communication Cell.

- 4. If the passengers refuse to take the tickets, the conductors of the said service shall educate the passengers properly duly informing the financial position of the Corporation and even after they refuse to take the tickets, the Conductor shall stop the bus aside and inform the situation to the Depot Manager.
- 5. As per the existing rules, the Conductor has to issue tickets to all passengers before start of the bus. The Conductors shall have the Telephone Numbers of DM/AM(T) of the Depot and shall inform the DM/AM(T), in case of any incident of refusal to take the ticket/untoward incident, who shall in turn inform the same to the Police Authorities for help. The DMs/A.Ms(T) shall have the Telephone Numbers of all Police Stations and police officials with them.
- 6. The Chief Commercial Manager of Corporate Office shall deploy the Hqrs. Enforcement Squads for patrolling with clear instructions to the TTIs to inform the situation to the respective Depot Managers from time to time.
- 7. The Executive Directors of the Zones shall constantly move on line and monitor the situation with the Regional Managers and guide them properly from time to time.
- 8. The Executive Directors shall depute Sr.Scale Officers to sensitive Depots like Siddipet, Medak etc., to ensure proper operation of services.
- The DMs shall attend the depots in early hours by 05.00 AM during the period of Non Cooperation.

The Regional Managers are requested to take all possible efforts to tackle the sensitive issue with active cooperation of Unions, Employees and the Passengers for smooth conduct of operations.
