Sub : CONCESSIONAL ANNUAL TRAVEL (CAT) SCHEME- Continuation of the Scheme as a Permanent Marketing Strategy and change of term of 'Insurance' - Communicated - Regarding.

I. Through the Circular cited at ref. a scheme christened CAT(Concessional Annual Travel) Scheme was introduced w.e.f. 1.1.2000 for a period of one year.

II. It is decided to continue the scheme as a PERMANENT MARKETING STRATEGY owing to its overwhelming response.

III. Further, it is to inform that we have withdrawn tie-up from M/s Oriental Insurance Company Limited. However, we have decided to pay Rs.1.00 lakh as "Additional Compensation" in the event of death of a CAT card holder due to injuries sustained in any accident to the vehicle in which the CAT card holder is travelling. This "Additional Compensation" will be paid after complying with the formalities as mentioned below vide Circular:77/95-OPD(C) Dt.29.11.95:
(i).Police F.I.R. (ii).Post Mortem Report (iii).Death Certificate issued by VAO/EO of Panchayat/MRO, Registrar of Births and Deaths etc. (iv).Nominated Legal heirs/Family Members declaration certificate (as stated in CAT Application form) containing the list of all eligible members issued by MRO/RDO, Collector/Court (v).Willingness letter (in triplicate) (vi).Money Receipt (in triplicate) (vii).Discharge voucher on a non-judicial stamp paper etc.


This amount will be paid in addition to the compensation that may be ordered by the Motor Accident Claims Tribunal concerned or that may be granted as out of court settlement or settlement in any Lok Adalat.

The existing term of "ONE LAKH INSURANCE COVERAGE" printed on the reverse of the Card as well as on Application form, shall be changed as "ONE LAKH ADDITIONAL COMPENSATION".

Other Terms & Conditions notified through earlier Circulars/Letters remain un-altered.
