CIRCULAR NO.41 /2007 –OPD(P) , Dated 29.11.2007.

Sub: **RESERVATIONS:-** Reservation of seat for exclusive occupation of Hon'ble MLAs/MPs/MLCs – Painting on the back side of the seats already specified for MPs/MLAs as Reserved for MPs/MLAs/MLCs – Instructions – Issued – Reg.

Detailed instructions were issued vide Circulars 1st & 2nd cited with regard to reservation of seats for exclusive use by the Hon'ble MLAs/MPs, Ladies, Physically Disabled persons, Senior Citizens etc. in all types of buses of the Corporation.

Vide Circular 3rd cited, instructions were issued to honor MLCs and their Spouses on par with MLAs and MPs and to allow the MLCs and their spouses to travel free by all types of buses including Volvo buses of APSRTC on the strength of their Identity Card without insisting for payment of fares duly providing reservation.

The Hon'ble MLCs are complaining about the non display on the back side of the seats that “the seats are reserved for MPs/MLAs/MLCs” and still it is continued as “Reserved for MLAs & MPs” thereby MLCs are facing hardship while occupying seats and for reservation of seats.

In view of the above, all the Depot Managers are therefore advised to repaint in all types of buses on the back side of the seats where the seat numbers are already specified for Hon'ble MPs/MLAs as

“ RESERVED FOR MPs/MLAs/MLCs”

All the Regional Managers are therefore advised to issue instructions to the Units under their jurisdiction for strict implementation of painting on the back side of the seats as detailed above for easy identification by Hon'ble MPs/MLAs/MLCs and to reserve the seats and also to educate the crew / booking clerks, Bus Station Managers accordingly
