Attention is invited to this Office Circular cited, wherein instructions were issued to implement the revised fares in respect of all types of stage carriage services of the Corporation w.e.f. 06.10.2000 and to over stamp the following denomination of tickets in respect of district ordinary services to tide over the situation consequent to the fare revision.

Instances were brought to the notice of this Office that some old ticket blocks (to be over stamped) have been sold without over stamping and some ticket blocks were over stamped twice contrary to the standing instructions in vogue in this regard.

The matter has been examined in detail and it is decided to dispense with the system of over stamping of tickets of district ordinary services w.e.f. 01.02.2001 as there are sufficient stocks of required (new) denominations available in the Central Stores, Miyapur.

The Unit Officers are hereby advised to draw the required stocks of all denomination of tickets in respect of district ordinary services in advance from Regional Stores/Central Stores and feed the new ticket stocks in the Computer and arrange to issue to the conductors by 01.02.2001. There shall not be any over stamped ticket blocks in the conductor trays after 31.01.2001.

The Unit Officers are hereby advised to take action to destroy the obsolete tickets in respect of district ordinary services after 31.01.2001 as per the Circular instructions duly obtaining the sanction from the competent authority and following the prescribed procedure.

The existing system of over stamping in respect of city / town services will continue until further orders. However, the Unit Officers of City Depots are hereby advised to ensure that the ticket denominations are over stamped properly as per the instructions issued. If any instances of double over stamping of ticket blocks or old ticket denominations without prescribed over stamping are noticed (even if the conductors are remitting the cash as per the revised value of the ticket denominations), the matter will be viewed seriously.
