**SUB : AUTHORISED TICKET BOOKING AGENTS - Payment
of commission - Rationalisation.**

Corporation has been appointing Authorised Ticket Booking Agents for selling the tickets of special type services.

Guidelines have been issued from time to time through the circulars cited with regard to payment of commission to the Agents. The commission payable was Rs.5/- per passenger ticket sold prior to February, 1998. To induce the Agents to sell more tickets, the commission was enhanced from Rs.5/- to Rs.10/- per passenger ticket sold with effect from 15.02.1998 vide circular cited at reference 4.

Of late, it has come to light that reservation facility has been extended to medium distance routes also with an aim to provide comfortable journey by making the tickets available in advance, not only through our counters but also through the agents. Commission paid in such cases was found to be on high side. Further, it has also come to our notice that the commission of Rs 10/- is being paid on sale of child ticket also.

Therefore, the matter has been examined and payment of commission has been rationalised. A slab of revised rates of commission payable to the Agents is given below :

VALUE OF TICKET	COMMISSION PAYABLE TO AGENT PER SEAT SOLD
1. UPTO RS.75/-	RS. 5/-
2. RS.76/- .& ABOVE	RS.10/-
3. HALF TICKET (CHILD TICKET)	50% OF COMMISSION PAYABLE ON ADULT TICKET

The above revision is applicable to the Agents functioning at all the places except Twin Cities of Hyderabad and Secunderabad where the payment of commission is according to the Tender conditions.

Above revision shall come into force with effect from 01.09.1999.

The Unit Officers are, therefore, advised to implement the above and report compliance.
