**CIRCULAR NO.05/2011-OPD(P), Dtd.21-02-2011.**

Sub: **HIRING:** Hiring of private buses - Tyres Cost - Payment of variance in cost of tyres due to escalation in the cost of tyres - Recommendation of Committee to pay 1 Ps. per km. to Exp. buses of 2007 and 6 Ps per km to Mini buses of 2008 - Instructions for payment by way of adding it to prevailing hire rate w.e.f. 01.02.2011 - Reg.

It is to inform that provision is made in the Hire Tender Notifications issued in the months of March, May, June, July ( *issued in HCZ only* ), August, October, December 2007, May 2008 and January 2009 Notifications for revision (increase / decrease) of the hire rates in line with revision in price (increase / decrease) of tyres and wages of drivers and cleaners. However the periodicity to review the tyres cost is once in a year and wages cost will be once in two years.

A Committee has been constituted to review the revision (increase / decrease) of rates of hire buses for Notifications as indicated above in line with revision in cost (increase / decrease) of tyres. The Committee recommended for payment of 1 (One) Paise per km. towards difference of cost of tyres for Express buses of 2007 Notifications and 6 (Six) Paise per km to Mini buses of May 2008 Notification.

V.C. & M.D. with the concurrence of C.A.O. approved the above recommendations of the Committee and ordered for implementation.

It is therefore requested to enhance 1 paise per km towards all Express type hire buses which were introduced in pursuance to the Hire Tender Notifications issued in the months of March, May, June, July (*issued in HCZ only.*), August, October and December 2007 and all Express type hire buses which were supplied as replacements to old model hire buses in pursuance to the Notification of hire buses during the year 2007 and 6 paise per km towards Mini buses of May, 2008 Notification as entitled to be paid, towards difference in cost escalation of tyres, w.e.f 01.02.2011 only, subject to pre-audit.

Instructions regarding payment of arrears will be issued later.
