Sub: ACCIDENTS: Payment of compensation in accident cases - Evidence to be built up by calling photos of accident spot - Instructions issued - Regarding.

Of late, there has been spurt in number of ghastly accidents. Such accidents not only result in tarnishing the image of the Corporation among people, but also lead to payment of huge amounts towards compensation.

The particulars of number of fatal and major accidents occured during the last three years and upto August. 2001 during this financial year and the quantum of compensation paid are furnished hereunder for ready reference.

Drivers of the corporation may not be responsible for all the accidents. But we are compelled to pay huge compensations due to lack of sufficient evidence, or on account of non-adducing of proper evidence before the courts.

The quantum of compensation to be paid, can be reduced to the extent possible by producing proper evidence. The Photos of accident spot are important evidence.

The Depot Managers are therefore advised to arrange for taking Photos of accident spot in different angles before the vehicle is removed from the actual spot by the Police authorities. The negatives of the Photos should be preserved and printed copies produced in the Court at appropriate time.

Sketch of the accident spot should be drawn indicating the position of the vehicles, road width, length of skid marks, geometry of the road, length from nearest kilometrestone or important built-up area from the position of the vehicle.

All Depot Managers should follow these instructions in letter and spirit and the Executive Directors/Regional Managers/Divisional Managers should ensure that these instructions are adhered to, so as to reduce the quantum of compensation being paid.
