Bub: ADVERTISEMENTS: Providing various facilities to the passengers of Mayori/Hi-Tech buses like Audio/Vedio systems, cell-phones, sale of snacks and Cool Drinks through attenders etc. by entrusting job to private agencies, with rights/without rights for advertisements. Instructions issued - Recording.

1. INTRODUCTION:

Of late, there has been tremendous awareness on quality of service being provided to customer in all sections of the Society. In a state of liberalised economy "Customer Satisfaction" has assumed paramount importance, to any business organisation. The need, has, therefore, arisen even for public sector undertakings to take utmost care of the needs of their customers.

11. ADDITIONAL AMENITIES TO BE PROVIDED:

The Corporation has already earned reputation as a trend-setter in providing various amenities in bus stations, to the travelling public. In addition to the amenities provided in various bus stations, the additional facilities like audio/video systems, the attenders with provision for dispensing snacks, cooldrinks, supply of news papers and magazines in Hi-Tech/Mayuri buses are in existence. Still, there have been spate of complaints on non-functioning or defective functioning of these systems, which ultimately loads to dispatisfaction among the travelling public.

Therefore the following instructions are issued on provision of additional amenities.

(A) MAYURI & LUXURY BUSES:

- Provision of audio system in Mayuri & Luxury buses, wherever required and its maintenance.
- (ii) Provision of Attenders in Mayuri bases.
- (iii) Provision of Cell-phones in Mayuri buses

(B) HI-TECH BUSES:

- (i) Provision of audio & video systems in Hi-Tech buses where such amenities are not available and their maintenance
- (ii) Provision of Attender
- (iii) Provision of Cell phones
- It is proposed to provide above amenities, through agents in Mayuri, Hi-tech and Luxury services with rights for advertisements to be appointed by calling for tenders at Regional level.
- (C) The Agent, will provide and maintain the audio/video where the system is not existing in our buses. He will be permitted to display advertisements through both audio and video systems. Further, the agent is required to pay the contract amount to the corporation.

or :

- (D) The agent will be paid by Corporation for provision and maintenance of Audio & Video system without rights for display of advertisements in Audio & VIdeo Systems in Hi-Tech/Luxury buses duly calling for tenders.
- The work sheet/guidelines showing the maximum amount payable to the agent is appended to this Circular. If any Tenderer quotes less than this amount, the same may be accepted duly negotiating, if need be.

In order to maintain uniformity in appointing advertisement agencies in various Regions, the terms and conditions are formulated. The model tender notification, tender form, terms and conditions of the tender are enclosed for ready reference and further necessary action.

III. TENDER COMMITTEE:

Since the tenders are to be called for and finalised at regional level, the Regional Tender Committee shall be constituted with the following officers.

1) Regional Manager (2) Divisional Manager stationed at the headquarters of the region (3) Dy.Chief Accounts Officer / Accounts Officer of the Region.

The proceedings of the tender committee shall be approved by the Executive Director of the Zone.

If any existing TV/VCPs are not functioning in Hi-Tech Buses, Regional Managers are advised to get them repaired through the concerned Dy.Chief Mechanical Engineers from private agencies locally and ensure that TVs/VCPs are in working condition.

It is our endeavour to ensure commuter satisfaction and improve efficiency of the amenities in the coach.

The Regional Managers shall therefore take immediate action.

- 1. (a) The Tender is for appointment of Advertising Agent for i) Provision and maintenance of Audio and Video systems in Hi-tech buses (ii) Provision and maintenance of Cell Phones in Mayuri/Hi-tech buses (iii) Provision of Attender in Mayuri/Hi-tech buses and (iv) Provision and Maintenance of audio system in Mayuri/Luxury buses of ______ Region *with/without rights of advertisements through video/audio system to be provided in the above mentioned type of buses.
- (b) The particulars of buses available depot-wise and type-wise are furnished in the enclosed statement.
- (c) The successful bidder shall have to offer the contract amount proposed to be paid to the Corporation at Column No.8 of tender form. If the tenderer does not require the advertisement rights the amount expected from the Corporation shall be quoted at Column No.9 of the tender form.
- 2. The period of contract is FIVE YEARS only.
- 3. The tender must be submitted in the prescribed Tender Form. The tender form is not transferable. The Tender form must be signed by the tenderer only.
- 5. The EMD will not carry any interest. The EMD of the unsuccessful tenderers will be refunded only after finalisation of Tenders. The Corporation shall not be responsible for any delay in refund of EMD due to reasons beyond its control in finalising Tenders viz. Court directives etc.

In case, EMD paid by the Tenderer is less than what is stipulated in the Tender notification or the EMD paid is through other means i.e., in a manner other than the stipulated in terms and conditions, the Tender will be rejected and the EMD amount will be forfeited.

The EMD amount of unsuccessful tenderers will be refunded after finalisation of tenders.

- 6. The Tender form duly filled in, alongwith Demand Draft in original towards the EMD amount prescribed, sealed in a cover should be placed in a Tender box, provided in the office of the Regional Manager, Region upto 14.00 hours on The Tenders received after the stipulated date and time will not be accepted. Tenders will be opened at 15.00 hours on the same day by the Tender Committee.
- 7. Tender form not accompanied by the Demand Draft, towards E.M.D. incomplete Tender form and tender form with any preconditions or additional conditions will be rejected and the EMD amount will be forfeited.
- 8. a) The tenderer shall quote the year-wise contract amount payable to the Corporation, in column 8 of the tender form if the offer is for provision and maintenance of audio/video systems in addition to provision of Cell-phone and Attender, with a right to display of advertisement.
- b) If the offer is for provision and maintenance of audio/video system in addition to provision of Cell-phone and Attender, without rights of advertisement, then the amount expected from the Corporation, shall be quoted vide column No.7 of the tender form.
- c) The year-wise contract amount payable to the Corporation shall not be less than 15% or more than 25% of the total contract amount quoted for the entire period of five years.
- d) The contract with advertisement rights will be awarded on the basis of highest amount offered for the five year contract period, subject to clause (a) & (c) above.
- e) The contract without rights of advertisements, will be awarded on the basis of the lowest amount offered for the five year contract period.
- f) If the successful Tenderer backs out from taking up the contract for what so ever reason, the EMD paid by the Tenderer will be forfeited.
- g) The Corporation shall not be responsible, for the delay in finalising the tenders for reasons beyond its control viz. court directive etc.
- h) The Corporation reserves the right to reject any or all Tenders without assigning any reasons. The tender once submitted shall not be permitted to be withdrawn.
- I) The contract amount payable by the advertising agent to the Corporation, shall be paid as under:

- i) The amount payable for each year shall be divided into 12 equal monthly instalments and the advertising agent shall pay each instalment amount before 10th day of every month to the Regional Manager ----- Region.
- ii) The advertising agent shall pay the monthly instalment of contract amount at a time. No part payment towards monthly instalment amount will be accepted.
- iii) In the event of delay in payment of monthly instalment amount, the advertising agent is liable to pay interest for each day of delay beyond the due date at 36% per annum upto a maximum period of 90 days after the due date, in addition to the instalment amount. Recurrence of delayed payment, for more than six occasions is liable for termination of contract.
- iv) The amount payable by the Corporation, for the contracts without rights of advertisements, will be paid once in a month within one week from the date of submission of the bill with necessary certifications by the concerned Supervisors and subject to pre-audit.
- 7) The successful tenderer shall deposit with the Corporation an amount equivalent to six monthly instalments of the contract amount to be paid to the Corporation/payable by the Corporation each year towards Security Deposit. The Security deposit shall not carry any interest. The Security Deposit is refundable on expiry of the contract period subject to satisfactory performance and fulfillment of agreement conditions.

The successful tenderer shall enter into an agreement for undertaking the above work on prescribed terms and conditions'with the Regional Manager ______ Region.

- 10) The Security deposit paid by the Contractor is liable to be forfeited in the event of non performance of the contract or for breach of any of the terms and conditions of the agreement.
- 11. The successful tenderer to whom the contract will be allotted shall have to undertake the work for a minimum period of one year from the date of entering into an agreement. If he/she desires to discontinue the contract for whatsoever reasons, before completion of minimum period of one year of contract, he/she has to pay the balance of amount which falls short of the amount equivalent to one year remuneration in addition to forfeiture of security deposit.
- 12. On expiry of the period of contract or on its termination, as the case may be, the contractor shall handover the equipment provided by the Corporation, if any to the Depot Managers concerned.

- 13. a) The contractor will be permitted to display advertisements on the video casettes/ Disc upto 30 mts. duration in each Video Cassette and 10 mts. in each Audio Cassette/CD.
- b) The Contractor shall supply only good quality cassettes/CDs which are having original copy right and certified by the appropriate authorities, and they shall be periodically replaced. The Contractor shall obtain the approval of Regional Manager/Divisional Manager/Depot Manager before using in the bus. In case any complaint is received against the Casettes/CD's used in the buses penal action will be taken against the contractor.
- c) The Contractor shall arrange to play the audio/video systems provided in the buses by providing his own audio/ video cassettes/VCDs. The Contractor will also take up repairs duly providing the required spares to audio/video at his own cost for the system provided by him.
- d) The contractor shall bear the cost of damages caused to the system appliances/instruments, if any to the Audio/Video equipments provided by the Corporation and in case of theft of Audio/Video equipment fitted to the bus, the contractor has to replace with a new one during the subsistance of the agreement period including the repair charges during the regular maintenance period.
- e) The Corporation is not liable for any loss of Audio/Video systems including Cassettes provided in the buses by the contractor.

14. DISPLAY OF ADVERTISEMENTS

- a) The tenderer shall make his own arrangements for procuring necessary equipments like colour TVs of 21" size VCD/VCP/Invertors/Audio systems/casettes/CDs etc. and arrange to fit in the space provided in the Buses of APSRTC for carrying out his business.
- b) Further, the Casettes/CDs that are played in Audio/Video systems shall have authentication of the proper authority for display.
- 15. a) The advertisement displayed on Audio/Video systems shall not be of objectionable nature.
- b) The Contractor shall not display advertisement concerning Tobbaco, Liquor, Alcoholic and Narcotics products.
- 16. a) The contractor shall arrange to supply atleast 2 video casettes and 6 audio casettes in each bus.
- b) The Attender has to ensure that playing of Audio/Video system shall be upto 23.00 hrs and shall not cause any inconvenience to the travelling public.

17. PROVISION OF CELL PHONE

The tenderer shall provide Cell phone in each Mayuri/Hi.tech bus at his own cost, and provide service to the Passengers to make use of the Cell phone through Attender on "FAY & USE BASIS"

18. PROVISION OF ATTENDER

- a) The tenderer shall provide one attender in each bus at his/her own cost. In other words the wages shall have to be paid by the contractor.
- b) The attender shall operate the audio/Video system provided in Mayuri/High-Tech buses.
- c) The Attender shall make available the cell phone facility to the passengers by collecting the requisite charges. The attender shall sell refreshments, to the passengers, help the passengers in loading, unloading the luggage. The attender shall look after distribution / collection of magazines, news papers, seat head rest covers bed rolls, pillows, bedsheets provided by the Corporation. The Attender shall attend dusting and cleaning of buses at the terminals before commencement of the service.
- 19. a) The tenderer should not engage persons below the age of 16 years and above 60 years of age to work as Attenders.
- b) The tenderer shall provide full uniform to the attender at his own cost. The pattern of uniform will be decided by the corporation. The Attender shall attend his duties in full uniform.
- 20. a) The Attender should render their services to the passengers with utmost courtesy
- b) No bus pass/identity card will be issued to the Attender by the Corporation.
- c) The Attender shall not entertain any courier or accept unauthorised luggage for transportation
- 21. a) The Attender shall travel in the bus and during the course of journey he has to sell the following items at the rates specified below. These items shall be procured by the Contractor and be made available to the Attender to sell in the bus.
- i. Mineral Water bottles : Shall be sold at the rates not sachets/ : more than the MRP rates indicated on the products.

- b) The Attender shall circulate the Menu cards certified by the DM concerned indicating the rates of the items prescribed above before commencement of the journey.
- c) . The Contractor shall ensure supply of Cool Drinks and eatables in hygenic condition with good quality. The officials of the Corporation are empowered to inspect the items being sold by the Tenderer to the passengers and whenever reasonable standard of hygiene is not maintained or noticed substandard quality of the items are sold the officials have the right to impose fine/penalty of not less than Rs.500/- on each occasion.
- d) The Attender shall not sell any items other than the items mentioned in the Menu card. He shall sell only the items mentioned above to the passengers travelling in the bus during the journey period. The Attender shall not sell the items in the bus stations or terminals.
- 22. In case of termination of contract due to breach of terms and conditions of the agreement all the equipments, Cell Phones, audio/Video systems, invertors, cassettes, shall become the Corporation property, and the Contractor shall have no right over them.
- 23. The Contractor has no right to demand operation of any bus/buses on any particular route/routes/area/timings etc.
- 24. In case if any bus/buses with TV/VCP is not operated due to mechanical breakdown/accidents/strikes/bundhs, or for any other reason, the Corporation is not liable for any loss or damage caused to the contractor and he/she shall have no right to claim any compensation or reimbursement of loss etc.
- 25. The Attender shall take care of the equipment provided by the Contractor and any loss or damage is caused, the Attender shall solely be held responsible.
- 26. The Contractor shall pay minimum wages to the Attender engaged by him at the rates not less than the minimum wages as notified by the Government from time to time, in the presence of the Depot Manager/Supervisor, failing which the difference of wages will be deducted from the Security deposit of the contractor.

- 27. The Contractor has to obtain licence from the Licensing Officer under contract Labour (Regulation and Abolition) Act 1970 to carry out the work entrusted to him under this Agreement and submit a copy of the same before commencement of the contract.
- 28. The Contractor has to comply with all the provisions of the Acts of Government relating to Labour and Rules and Regulations made thereunder from time to time like Contract labour (R&A) Act 1970; payment of minimum wages, provident fund, EDLIF, ESI etc., as prescribed by the appropriate Government from time to time and submit the proof of compliance.
- 27. a) The contractor shall remit the PF/EDLIF amounts in respect of the persons engaged by him, to the Regional Provident Fund Commissioner on the code number obtained by him and produce the proof of the same every month to the Unit Officer to accept payment of monthly licence fee. If he is not allotted with the code number of the RPF Commissioner the amounts are to be remitted into the Provident Fund (Trust) of the Corporation APSRTC. Similarly, he has to remit the ESI contributions to the ESI authorities and produce the proof to that effect every month to the Unit Officer.
- b) The contractor is liable for all obligations arising out of this contract in respect of labour engaged by him.
- c) The Contractor has to contact the Labour Department and to maintain registers as required under law and as required by the Corporation and the same has to be produced for verification of the inspecting officials.
- 30. a) No compensation shall be paid by the Corporation for any injury/disability of any kind or death of the workers engaged by the Contractor within the premises of the contract area. The Contractor is liable to bear all the expenses and compensation in such cases. The contractor shall satisfy the ANDHRA PRADESH STATE ROAD TRANSPORT CORPORATION, the arrangements made by him to fulfill his obligation arising out of this clause by way of insurance policy.
- b) The Contractor shall insure the lives of the Labour engaged by him for any eventual risks that might crop up in the event of any accident.
- 31. The Contractor is liable to pay the damages, if any CAUSED TO THE PREMISES OR MOVEABLE/IMMOVEABLE PROPERTY OF THE CORPORATION by him or by his representatives, as determined by the Corporation. The Corporation shall have the right to recover such amounts towards damages caused from the security deposit of the Contractor.

- 32. The Contract shall be terminable with a three months advance notice on either side. However the Contractor is not entitled to terminate the contract during the first year. The Corporation shall have the right to terminate the Contract with a month's notice, if in its opinion, the service is not satisfactory and its decision in this regard shall be final. The Security deposit is liable for forfeiture in case the contractor terminates the contract without giving three months notice to the Corporation.
- 33. In case of misbehaviour, assault on employees of Andhra Pradesh State Road Transport Corporation by contractor/representatives/workers will lead to imposition of penalty or termination of contract duly forfeiting the Security deposit in addition to legal action.

The contractor is liable for imposition of penalties upto Rs.1000/- in case of complaints from the Public on the performance of the contract and the same will be recovered from the contractor.

- 34. The contract is liable for termination in the event of the contractor failing to do the business/service continuously.
- 35. In the opinion of the Corporation, if the Contractor fails to execute the contract for the terms mutually agreed to in the Agreement, the Corporation has the right to take any of the following actions:
- a) Imposition of fine for breach of contract by authorised Officer of the Corporation not below the rank of DM/ATM (it does not preclude inspection and imposition of fine by any authority superior to above authorities).
- b) Forfeiture of Security deposit either partly or fully.
- c) Termination of contract by giving one month's notice.
- d) Termination of contract with the notice and also simultaneous forfeiture of security deposit partly or fully.
- 36. In the event of death of the contractor, the contract cease to exist. However, the Corporation may permit the legal heir of the contractor to run the business on the same terms and conditions for the remaining period of contract, on execution of fresh agreement, by such heir only.
- 37. The contractor should adhere to all acts and laws in force, applicable to his business and for any violation of such laws, the sole responsibility lies with the Contractor.

The workers employed by the Contractor shall not have any right or claim whatsoever for employment in A.P.S.R.T.C. at a future date.

If any statutory authority imposes any penalty/fines etc., and if the Corporation is made a party in such penal action, for any acts of violations or commissions or omitions made by the Contractor, the Corporation has got the authority to keep such amount of the contractor like security deposit or any other amount, due to the Corporation etc., with it until it is proved to the satisfaction of the Corporation that such penal actions are ceased.

In case of any dispute on the terms and conditions of the tender, the decision of the Managing Director APSRTC shall be final and binding on both the parties. .***.
