**SUB: RESERVATIONS:** Advance booking of tickets for journey by corporation buses **Collection of reservation fee - enhancement of the fee** from Rs.5/- (five rupees) per ticket to **Rs.10/- (ten rupees) per ticket.** - **Instructions - issued - Reg.** 196



In accordance with the provisions of Rule 249 of APMV Rules 1989, Corporation is at present charging Rs.5/- (five rupees) per ticket as reservation fee from the passengers reserving accommodation in advance for travel by the buses of the Corporation operating on long distance routes.

The Government vide G.O. cited above has sanctioned enhancement of the reservation fee from Rs.5/- (five rupees) per ticket to Rs.10/- (ten rupees) per ticket.

All the Unit officers are therefore advised to implement the collection of enhanced fee of Rs.10/- (ten rupees) per ticket for reservation of seat at all Bus Stations, reservation counters, wherever advance booking facility is provided. This revised fee of Rs.10/- (ten rupees) shall come into force **with effect from 05-11-2011.**

Revised reservation charges shall not be collected from passengers who have reserved their seats before the intervening midnight of 04<sup>th</sup>/05<sup>th</sup> November 2011 irrespective of the date of journey for which such seats have been reserved. **NOTIFICATION:**

In exercise of the powers conferred by Section 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Government of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Motor Vehicle Rules of 1989, published with the Transport, Roads & Buildings (Transport-II) Department Notification dated the 7<sup>th</sup> August, 1989 at pages 1-315 of the Rules supplement to Part-1 of the Andhra Pradesh Gazette, dated 25<sup>th</sup> August, 1989, the same having been previously published as required by Sub-Section (1) of Section 212 of the said Act.
