Sub: **BUS PASSES** – Providing free transport facility by buses to Pregnant Women for medical check up from their native village to nearest PHC / Govt. Hospital and back – Policy of the Govt. of India – Working instructions issued – Reg.

INTRODUCTION :- The Commissioner of Family Welfare & Ex-Officio Secretary to the Government (HM & FW Dept.), Government of A.P. vide the letter cited has informed that the Government of India have launched a Child Health Project Phase-II for A.P. from 2005 to 2010, under which free travel by public transportation buses would be provided to “Pregnant Women” from their native villages to nearest PHC / Govt. Hospital and back.

FREE TRAVEL SCHEME :- The Department of Family Welfare, Government of A.P. have therefore proposed to have a scheme for providing free transportation of rural Pregnant Women who are Below Poverty Level (BPL) by Andhra Pradesh State Road Transport Corporation buses in the rural areas of A.P. State, to enable them to visit the nearest PHC / Govt. Hospital during pregnancy period to have antenatal check-ups. The Government have also decided to implement this scheme for a period of one year initially, and the same would be reviewed thereafter for continuation.

DECISION OF THE CORPORATION :- The request of the Commissioner of Family Welfare, Government of A.P. has been examined. It is decided to allow free travel facility to the Pregnant Women for their travel in District Ordinary and Express buses from their respective native village to the nearest PHC / Govt. Hospital and back.

IDENTIFICATION OF THE BENEFICIARIES :- The beneficiaries of the scheme will be identify the Office of the Medical, Health and Family Welfare Department and **Identity Card-cum-Bus Pass will be issued by the authorized signatory of the Department.** From the APSRTC side Executive Director (O) will be authenticating the identity cards to be issued by the Medical, Health and Family Welfare Department.

VALIDITY OF THE CARD :- The Identity-cum-Medical Cards issued to the pregnant women authorized by ED(O) only are valid to perform 3 (three) free round trips (3 Up & 3 Down journeys) for medical check up on all Ordinary and Express buses operating on the sector.

The Identity Card-cum-Bus Pass is valid between the places mentioned therein, and valid upto the date mentioned in the card.

WORKING INSTRUCTIONS TO OPERATING STAFF :-


1. The Identity Card-cum-Bus Pass is intended to ensure hassle free transport to Pregnant Women.
2. Wide publicity among crew and supervisors is to be undertaken through Notice Boards and Gate meetings. Specific endorsements are to be made in conductor's instruction card (i.e., MID 141).
3. The Conductor (or Driver in case of TIMs services) shall allow the Pregnant Women holding medical card signed by the Executive Director (Operations) of the Corporation to perform free travel from the village mentioned therein to the nearest PHC / Govt. Hospital (Mandal / District Headquarters) mentioned in the bus pass, and vice versa in the return trip.
4. The Conductor (or the Driver as the case may be) **shall invariably punch in the space provided on the Identity Card.** Model Identity Card-cum-Bus Pass is also enclosed.
5. The crew shall also be educated about the details of the scheme in the ensuing "MANA CHETILONE MANA BHAVITHA" Programme.

Corporate Office has already claimed the cost of free travel in lumpsum for Rs.1.5 Crores from the Commissioner, Family Welfare Dept., Govt. of A.P., Hyderabad.

All the Depot Managers / their representatives are, therefore, advised to attend the meetings if called for by the Medical Officers in their respective jurisdiction for any clarifications.

This scheme has the concurrence of the Financial Adviser. This scheme shall come into force w.e.f. 14.02.2006.


