CIRCULAR NO.08/ 2013-OPD(P), DT.11.03.2013.

Sub: RESERVATIONS – Reservation of seats in all types of buses for exclusive occupation of reserved categories like Legislators/Ex Legislators & MPs, Senior Citizens and Physically Disabled persons -Increase in Seats reserved to PHCs in APSRTC buses -Instructions issued – Reg.

Instructions were issued vide Circular 2<sup>nd</sup> cited to the units to earmark 4 seats for Legislators/Ex Legislators/MPs, and 3 seats for Senior citizens and one seat for PHC persons in Pallevelugu, Express, Deluxe, Super Luxury and Garuda services. The seat numbers to be earmarked in the above services also communicated in the said circular.

The Hon'ble Chief Minister, Government of AP during Indiramma Bata has assured for " Enhancement of number of Seats reserved for Differently abled persons to Five in APSRTC buses".

Accordingly the Competent authority has accorded **approval to enhance the seats reserved for differently abled persons from one to two in all City type services (except AC type buses), District Express, Deluxe, Super Luxury buses and from two seats to three seats in Pallevelugu buses initially.**

Therefore the seats reserved to different categories like Legislators/Ex Legislators/MPs, Senior citizens and PHCs in various types of buses are furnished hereunder for strict implementation.

**I. MOFFUSSIL TYPE BUSES**

## II. CITY TYPE BUSES:

### a. Differently Abled Persons:

- **The first row left side 2 seats at front entrance of the bus** (Driver side entrance) in City Ordinary/M. Express/M. Deluxe has been reserved for Physically Disabled persons

### b. Senior Citizens.

- The two Seater in 2<sup>nd</sup> row and one seat on 3<sup>rd</sup> row on left front side entrance of the bus (Driver side) in City Ordinary/M. Exp /M. Dlx be allotted and earmarked to Senior Citizens only.

### c. Ladies:

- **40% of the remaining seats on front left and right side (other than the seats reserved for Senior Citizens and PHCs)** in City Ordinary/Metro Express /Metro Deluxe buses shall be allotted to ladies only

All other instructions communicated in the Circular 2<sup>nd</sup> cited shall hold good. However the instructions are reiterated hereunder for strict implementation

- i) In some of the City buses there is also one single seat provided besides the driver, which seat is allotted for lady passenger (wherever available).
- ii) If the reserved seats are not occupied by PHCs and Senior Citizens in City buses, these seats shall be occupied by women passengers only and the same should be printed on the side body panel of the bus, above the reserved seats.
- iii) The **two seats reserved** for PHCs be painted in GREEN COLOUR and **three seats reserved** for Senior Citizens be painted in WHITE COLOUR for easy identification and for occupation of PHCs and Senior Citizens respectively.

- iv) A slogan "VRUDHULAKU CHEYUTHA NIVVANDI" be painted in all the buses of the Corporation to extend helping hand to the Senior Citizens.
- v) The crew shall be instructed strictly to honor the Senior Citizens and Physically Handicapped persons while boarding and alighting the bus at the Bus Stops and while occupying the seats meant for them in all types of services.
- vi) **If the seats meant for Senior Citizens / PHCs are already occupied by others, the conductor shall pursue to vacate the seats facilitating the Senior Citizens / PHCs to occupy these seats.**
- vii) Any complaints of disrespect against operating crew from the Senior Citizens and Physically Handicapped persons shall be viewed seriously and action be taken against the concerned.

A report of compliance as having earmarked seats in all the buses in their Units as shown above be submitted to this Office by 01.04.2013.
