In view of implementation of revision of fares w.e.f.24.10.2015 vide reference 7th cited, the above commission rates are to be reduced to 2.76% and 4.12% for Non-AC services and AC services respectively, duly neutralizing the fare hike impact.


But, to motivate the ATB agents and B2C Franchisees to book more seats through OPRS, Competent Authority has accorded approval, with the concurrence of FA & CAO, to continue the existing commission rates payable to ATB agents and B2C Franchisees as furnished below:
