Sub:- Transport Department – Enforcement - Seized vehicles parked in APSRTC Bus Depots / Units by the Officials of Transport Department – Revision of rate of parking fee and to ensure that parked seized vehicles are cleared at the earliest – Reg.

I invite attention to the references cited.

I am to inform that in the year 2012, vide reference 1<sup>st</sup> cited, the rates of parking fees of seized vehicles kept in APSRTC Depots / Units were revised as follows;

1) 2 & 3 wheelers Rs.15/- per day per vehicle ... Maximum of Rs.750/-

2) LMV/LGV's Rs.25/- per day per vehicle ... Maximum of Rs.750/-

3) Heavy vehicles Rs.40/- per day per vehicle ... Maximum of Rs.750/-

In the reference 2<sup>nd</sup> cited the APSRTC informed that the parking charges revised in the year 2012 are very less in the present standards and the revenue realized towards parking fee of the vehicles seized is so less that even the wages of the Security Personnel posted to safeguard the seized property are not met. The APSRTC requested to enhance the parking fee of the seized

vehicles as proposed in the said letter. The proposal of the APSRTC is examined and agreed to. Hence, the revised parking fee payable by the registered

owners of the vehicles, category-wise, is as follows;

Category of vehicle	Revised parking fee per day	Maximum parking fee per vehicle
2 & 3 wheelers	Rs.30/-	Rs.1500/-
LMV / LGVs		Rs.2000/- Rs.2500/-
	2 & 3 wheelers	fee per day  2 & 3 wheelers Rs.30/-  LMV / LGVs Rs.50/-

Note:- In respect of seized vehicles which are not got released by the registered owners of the vehicles, and are auctioned, a fixed parking fee of @Rs.1000/- is payable once the vehicle is auctioned.

The above rates will come into force w.e.f. 10-01-2018.

I request you to take further necessary action in the matter.
