Vide Circular under 1st reference, instructions were communicated for both Telangana and AP on revision of floor rates consequent to revision in HSD price w.e.f 17-01-2015 to 16-05-2015.

Item no. 03. of the said circular contained the instruction to,

"increase / decrease the "allotted hire rates" of buses introduced vide December, 2014 notification as per the instructions issued vide circular Nos. listed below

During the year 2017 audit teams have pointed out that some of the regions have not implemented these instructions. Consequently clarification is sought by the respective regions on the applicability of the above mentioned circulars. Further vide letter in 2nd reference, the CAO also sought clarification on the applicability of the circulars listed above for vehicles introduced vide December, 2014 notification.

The issue has been examined in detail and the following revised instructions are communicated for strict adherence.

- The circulars mentioned in para 3 of circular 15/2015 listed above are not applicable for buses introduced vide December 2014 notification.
- The revision in rates w.e.f 17-01-2015 till 16-05-2015 shall be implemented as per the annexure for all buses introduced vide December 2014 notification.
