50% concession to the attendants of Freedom
Fighters - Instructions issued - Reg.

The Government of Andhra Pradesh vide G.O.Ms.No.241, dt.12.09.1994 issued instructions to provide free bus pass facility to Freedom Fighters above the age of 65 years and born prior to 13.09.1929. Accordingly, vide Circular No.52/94-OPD(P), dt.30.09.1994 Corporate Office issued guidelines to the Units to allow Freedom Fighters to travel free in all types of APSRTC buses, except in A.C. coach buses viz., Garuda Plus, Garuda/Indra, City Sheetal etc. and also be courteous towards Freedom Fighters.

Vide G.O. 2nd cited, Government accorded permission to provide 50% concession on fares of actual journeys undertaken by the attendants, whenever they travel along with Freedom Fighters in the State in all types of services up to Super Luxury and this facility is valid in all City and District Services except in A.C. services.

Accordingly it is decided to provide 50% concession on fares of actual journeys undertaken by the attendants, whenever they travel along with Freedom Fighters in the State in all types of services up to Super Luxury and this facility is valid in all City and District Services **except in A.C. services.**

All the Regional Managers are therefore instructed to advise the Field Officers / Supervisors to educate the Operating Crew, **that the Freedom Fighters are entitled to travel at free of cost (on the strength of Identity cum Free Bus Pass issued to Freedom Fighters) for themselves and @ 50% concession on the fares of actual journeys for attendants** in City/Sub-urban, Ordinary, Metro Express and Metro Deluxe buses and in District Ordinary, Express, Deluxe and Super Luxury buses. There is no bar on the gender/age of the attendant.
