Sub: BUS PASSES - Extension of concessional travel facility in
Air conditioned Buses to Journalists - Represented Communication of working instructions - Issued - Reg.

Government vide G.O.5th cited informed that in suppression of earlier orders issued vide G.O.2nd cited, agreed to provide in addition to the existing facility of travel in Non A/C buses, the journalists accredited by the State Commissioner of Information and Public Relations (about 1100 in number) will be extended similar facility in all the A/C buses services of APSRTC within the State i.e., the Journalist will pay 1/3rd of the Ticket Fare and Government will subsidize 2/3rd Ticket Fare.

Therefore in supersession of the earlier instructions issued vide Circular 1st cited, the following instructions are being issued for strict implementation by Unit officers/Operating Crew.

- The journalists accredited by the State Commissioner of Information and Public Relations (about 1100 in number) are only permitted to travel in all AC buses being operated by APSRTC with in the District, State and in Cities where City AC services are under operation at 2/3rd concession on normal fare on the strength of Bus Pass issued by Public Relation Officer, APSRTC, Bus Bhavan, Hyderabad.
- The journalists accredited by the State Commissioner of Information and Public Relations (about 1100 in number) will approach the Public Relation Officer (VC&MD office, 3rd floor, B. Block) to avail AC valid Journalist Bus Pass.
- o After thorough verification of accredition of Journalist the Public Relation Officer, APSRTC will issue the Journalist Bus Pass duly stamped on the Bus Pass as "AC TRAVEL IS PERMITTED".
- The State valid Journalist Bus Pass with "AC TRAVEL IS PERMITTED". Stamp and issued by PRO/VC&MD office, Bus Bhavan are only eligible to travel in all AC buses being operated by APSRTC with in the District, State and in Cities where city services are under operation.
- The Journalists Accredited by District Accredition committee under DPRO and issued with Journalist Bus Passes at Regional offices by Regional Managers are not valid to travel in all types of AC buses.
- The Public Relation Officer, VC&MD office should obtain the list of journalists having accredition at State Commissioner of Information& Public Relations and AC validity shall be extended to the Journalists as per the list provided by Government.. The PRO section, Bus Bhavan should maintain a separate register for AC valid Journalist Bus Passes.



- The intending accredited correspondent travelling in AC buses shall pay 1/3rd cost of Actual Fare and APSRTC will extend 2/3rd Ticket fare concession of Actual fare.
- The journey particulars of accredited journalists travelling in AC buses shall be recorded by operating crew in TIMS/STAR of the concerned service. At Depot level the actual cost of travel shall be arrived month wise and be submitted to Regional Managers concerned. The RM in turn shall arrange to consolidate the data along with other free/concessional bus passes and to send the Regional Monthly periodical to Head office.

Therefore all the Unit officers are strictly advised to issue instruction and guide the operating crew and Supervisors on above lines and notice board shall be exhibited at Despatch section and Earning section. The other terms conditions applicable to Journalists in vogue shall hold good.
