Communication of revision in HSD component in floor rates – Reg.



Vide letter under reference cited, instructions were communicated to units for implementation of revision in HSD component in floor rates till 31.05.2022. The Oil Companies have further revised the HSD Oil rate.

1. The ED's Committee reviewed the HSD component in floor rates separately to hire buses for the period from 01.06.2022 to 30.06.2022 and submitted recommendations for revision in hire rates payable, consequent to revision of HSD oil price. VC & MD has accorded approval for implementation of the revised rates as recommended by the ED's Committee with the concurrence of FA & CAO.
2. The existing floor rates **to be decreased** in respect of all hire buses pertaining to Tender Notifications issued from 2010 to December'2014 and to Express type hire buses introduced as replacement to old model buses of 2007 and 2009 (replaced in 2013 and 2015) as per the product wise table as at Annexure – A for the period 01/06/2022 to 30/06/2022.
3. The existing floor rates **to be decreased** in respect of all hire buses pertaining to November, 2015 tender notification and for Pallevelugu type hire buses introduced during the years 2016 to 2018 as replacement to old model buses as per the product wise table at Annexure –B for the period 01/06/2022 to 30/06/2022.
4. The revision in HSD component in floor rates are applicable for one year extended hire buses also.
5. All hire buses bills shall be pre-audited before releasing payment. These revisions are not applicable for vehicles introduced through MSTC I to V tenders and HSD top up at RTC units shall be ensured for these vehicles.

Detailed guidelines were communicated on topping up of HSD oil to hire buses at Corporation depots/garages and payment of net hire charges to the entrepreneurs excluding the cost of HSD Oil. It was also informed that the hire charges payable for the hire bus shall be calculated as per the applicable floor rate for each individual hire bus duly deducting the amount towards total quantity of diesel oil topped up to the bus in the month at the prevailing local market rate as communicated by the SPD from time to time.

Vide letter at reference cited, the market rate prevailing in the location of erstwhile Regional Managers office of APSRTC ( in case of NEC Region VZM & SKLM) was communicated to all the units of the Regions w.e.f. 1<sup>st</sup> May 2022.

The daily prevailing market price was communicated by SPD from 01.06.2022 to 30.06.2022. The average market price which is to be implemented **w.e.f 01.06.2022, as per the erstwhile Depots/Regions system is appended overleaf at Annexure – A** for arranging payment.
