Detailed guidelines were communicated on topping up of HSD oil to hire buses at Corporation depots/garages and payment of net hire charges to the entrepreneurs excluding the cost of HSD Oil. It was also informed that the hire charges payable for the hire bus shall be calculated as per the applicable floor rate for each individual hire bus duly deducting the amount towards total quantity of diesel oil topped up to the bus in the month at the prevailing local market rate as communicated by the CCOS from time to time.

Vide reference letter 1<sup>st</sup> cited, the market rate prevailing in the location of Regional Managers office of APSRTC (in case of NEC Region VZM & SKLM) was communicated to all the units of the Regions w.e.f. 1<sup>st</sup> Nov, 2018.

The daily prevailing market price was communicated by SPD from 01.11.2018 to 30.11.2018. The average market price was arrived which is to be implemented **w.e.f 01.11.2018** is appended overleaf at Annexure – A for arranging payment.
