The A.P. State Hire Bus Owner's Association has submitted a representation to extend the agreement period of Pallevelugu buses of 2010 &2013 Tender Notifications as the agreement period is expiring after completion of 9&7 years respectively and 2013 & 2014 notifications Express & Metro express buses as 6 years agreement period is expiring in the year 2020. Further, they also requested to accord permission for replacement of these old model buses with new BS-VI vehicles.

Upon the representation of Hire Bus Owners Association, keeping in view of the onset of Peak season and time involved in the process of calling tenders, pending ratification of the Board, the competent authority has accorded approval only for extension of agreement period to the following vehicles.

- > To extend the agreement period of hire buses whose tenure is expiring during the months from April to July 2020.
- > To extend the agreement period of hire buses of Kadapa and NEC Regions whose tenure is expiring in Feb & March 2020 also as these buses were not included in MSTC-V tenders.
- > To extend the agreement period of hire buses of EG Region whose agreement is expiring in Feb& March 2020 since no response is received in MSTC-V tenders.

Accordingly, the following instructions are issued for adherence and compliance.

To extend 2010,2013 (T/R) & 2014 notification Hire buses agreement period up to October, 2020 from the date of completion of agreement or till a new bus is replaced in its place either by RTC or Hire whichever is earlier for the hire buses whose total agreement tenure is due for expiry in the months of April 2020 to July 2020 in all regions.

• To extend 2010,2013 (T/R) & 2014 notification Hire buses agreement period up to October, 2020 from the date of completion of agreement **or** till a new bus is replaced in its place either by RTC or Hire whichever is earlier for the hire buses whose total agreement tenure is due for expiry in the months of **Feb & March 2020 also in Kadapa, NEC & EG Regions.**

The Regional Managers are here by advised to extend the agreement period of hire buses with the following conditions.

- There will not be any change either in the existing route with route course or in the vehicle utilization, for which a separate agreement has to be entered by the owner.
- The vehicle should be fit on all statutory/mechanical provisions and with Insurance coverage during the extended period of agreement.
- There shall not be any change in the hire rate payable during the extended period of agreement.
- Willingness of owner shall be obtained in writing for the proposed extension.
- The Regional Managers are advised to obtain willingness/unwillingness letters as at "Annexure-A" from the Existing operators and send consolidated statement to this office.
