Addendum to circular no.04/2020-OPD(P) Dt.20.02.2020

Sub:- **Hiring** – Hiring of private buses – Representation of Hire Bus Owner's Welfare Association, Andhra Pradesh for Extension of hire bus agreement period 2010 PVG, 2013&2014 Notification buses - Reg.

Ref :- Circular NO.04/2020 - OPD (PLG), DT.20.02.2020.

Upon the representation of Hire Bus Owners Association, keeping in view of the onset of Peak season and time involved in the process of calling tenders, pending ratification of the Board, the competent authority has accorded approval for extension of agreement period to the following vehicles.

Accordingly, the following instructions were issued vide circular at reference cited.

- To extend 2010,2013 (T/R) & 2014 notification Hire buses agreement period up to October, 2020 from the date of completion of agreement **or** till a new bus is replaced in its place either by RTC or Hire whichever is earlier for the hire buses whose total agreement tenure is due for expiry in the months of **April 2020 to July 2020 in all regions.**
- To extend 2010,2013 (T/R) & 2014 notification Hire buses agreement period up to October, 2020 from the date of completion of agreement **or** till a new bus is replaced in its place either by RTC or Hire whichever is earlier for the hire buses whose total agreement tenure is due for expiry in the months of **Feb & March 2020 also in Kadapa, NEC & EG Regions.**

In MSTC-Phase V tenders, the hire bus routes whose agreement period is expiring from January 2020 to March 2020 were also included. But some of the successful bidders have not purchased chassis so far and unwilling to produce new hire buses. In view of the above, the competent authority has accorded approval to extend the agreement period of said hire buses also upto October 2020.

Therefore, it is advised to extend the agreement period of above said hire buses up to October,2020 from the date of completion of agreement **or** till a new bus is replaced in its place either by RTC or Hire whichever is earlier **subject to non-issue of NOC and after ensuring unwillingness of the successful bidder for introduction of bus.**

The other terms and conditions issued vide circular cited shall hold good .

The provisional list of hire buses (certified by regions) whose agreement period is expiring upto July 2020 and eligible for extension up to October 2020 is enclosed here with for taking necessary action.
