Sub: Hiring: Hiring of private buses – Revision of floor rate in Tyre Cost for all the hire buses introduced vide December 2015 tender notification and Pallevelugu buses introduced during the year 2016 to 2018, as replacement to 2007 & 2008 notifications only - Reg.

As per the agreement of hire buses introduced, vide December 2015 tender notification and Pallevelugu buses introduced during the year 2016-2018, as replacement to old model 2007 & 2008 notifications “ the agreed hire rate allotted to the applicant will remain unchanged, till the total tenure of agreement period, except for revision of the hire rates (increase/decrease) once in a year, in line with revision in price (increase/decrease) of tyres. The periodicity to review tyres cost is once in a year.

Vide this office Circular at reference cited, instructions were issued to revise the cost component in floor rates of tyres to the hire buses of the said notification/replacements, after completion of one year period. Now, there is need to revise the cost component, in floor rates of tyres for the buses which have completed 2nd, 3rd and 4th year as the case maybe.

The committee constituted in this regard by the competent authority to review cost component in floor rates of tyres cost has submitted its recommendations which effective after completion of 2nd , 3rd and 4th year from the date of introduction of the respective hire bus.

The competent authority with concurrence of FA&CAO has accorded approval for revision of tyre component in the applicable floor rate on the recommendations of higher level committee.

Therefore, payment of hire charges shall be arranged after pre audit for all hire buses introduced vide December 2015 notification and Pallevelugu buses of 2007 and 2008 notifications replaced between 2016 to 2018 only as per the table after completion of respective period of agreement of hire bus.

The prevailing hire rate payable per km to the hire buses pertaining to notification/replacements referred to above, is to be **increased** per km in paisa, as indicated in the table furnished hereunder.
