Vide Circular Cited under 1st reference instructions were communicated to units for implementation of revised HSD prices till 31.12.2017 separately for buses introduced vide different notifications/replacements till 2014 and for buses introduced vide November, 2015 notification.

- 1. The Oil Companies have further revised the HSD Oil rate **daily from 01-01-2018**.
- 2. The Committee reviewed hire rates payable to hire buses and submitted its report recommending revision in hire rates payable, consequent to upward/downward revision of HSD Oil price. VC & MD accorded approval for implementation of the revised hire rates as recommended by the Committee.
- 3. The existing hire rates to be **Increased** in respect of all long wheel base hire buses pertaining to Tender Notification issued from 2007 to December'2014 and to Express type hire buses introduced as replacement to old model buses of 2007, 2008 (2013 tender notification)/2015 are placed at Annexure – A.
- 4. The existing hire rates to be <u>Increased</u> in respect of all hire buses pertaining to November, 2015 tender notification are placed at Annexure B
- 5. Vide letter 2nd cited, instructions were communicated to units for provisional increase of floor rate by 50 paisa. In view of communication of final floor rate wef 01.01.2018 vide this circular, this provisional increase of 50 Paisa shall be set off.
- 6. The payment of all hire buses bills shall be <u>pre-audited</u>. Please acknowledge.
