SUB: HIRING: Hiring of buses vide December, 2014 notification – revision of wage component in floor rate – instructions issued for payment of increased wage component and recovery/payment of dues in HSD Component - Reg

A provision has been made for all types of buses in the December, 2014 hire tender notification to revise the base floor rate (increase/decrease) in line with the revisions in wages of drivers. The prescribed periodicity to review cost component of wages in base floor rate is once, every year.

The Committee constituted by the competent authority to review cost component in floor rate towards wages of drivers has submitted its recommendations for payment of difference in increased wages over the existing wages.

The competent authority with the concurrence of FA & CAO approved the recommendations of the committee and ordered for implementation.

Therefore instructions are hereby communicated to arrange for payment of difference in wage component in floor rate to all types of hire buses introduced vide December, 2014 notification as shown at tables annexed at – A with reference to respective daily vehicle utilizations from the date of commencement of 3rd and 4th years subject to pre audit.


Vide Circular under 2nd reference revised guidelines communicated on correction in floor rates towards revision in HSD price for vehicles introduced vide December, 2014 notification.

Vide letter under 3rd reference it was further informed that the details of dues payable/recoverable shall be carefully computed and kept ready after pre audit and necessary guidelines will be communicated separately.

In continuation to the above, it is hereby instructed to recover the dues if any in full from the arrears payable and the balance shall be recovered in six monthly installments.

Further in case of any dues payable, payment of wage arrears shall be paid in total and arrears towards HSD component shall be released in six installments.
