SUB:: REORGANIZATION- HIRING- Amendment to the agreement with Hire bus owners in view of Reorganization of Zonal and Regional set up in APSRTC complying to the orders of Govt. of A.P – Instructions issued- Reg.

At present, APSRTC is operating 2425 hire buses(including MSTC VI Hire buses). In the previous Zonal & Regional set up, on behalf of APSRTC, Regional Managers used to enter into agreement with the hire bus owners.

The Government of A.P. vide Gazette notifications No 472 to 497, dated 03.04.2022 ordered for restructuring of 13 existing districts into 26 districts in the state of A.P. Later vide G.O. Ms. No. 92 of Finance (HR.I-Plg &Policy)Dept. dated 13.04.2022, the existing offices of Regional Managers have been restructured into 26 District Public Transport Offices, which shall function in line with the new districts formed by the state of A.P.

Accordingly, vide Circular No PD-03/2022, dtd.19.04.2022, instructions were issued on Reorganization of Zonal and Regional set up in APSRTC on the lines of Govt. of A.P.

On Reorganization of District setup, the District Headquarters of 67 depots got changed.

Example: Venkatagiri depot was under the jurisdiction of Nellore Region & Nellore Zone, previously. Now this depot falls under the jurisdiction of Tirupathi District & Zone-4 /Kadapa. The agreement of hire buses' was entered between RM/Nellore & H.B. Owners previously. After reorganization, the buses come under the control of DPTO/Tirupathi. Now there arises a need to enter into a new agreement between the concerned DPTO of new District and the Hire bus owner.

After careful examination, the competent authority with the concurrence of FA&CAO has accorded approval for the following instructions with regard to transfer of hire bus subject cases as per the present jurisdiction and to enter into agreement with Hire bus owners, as given below.

1. Subject cases of all the hire buses (agreements, legal cases, insurance, court cases, transfer of ownership, HO approvals if any, etc) shall be transferred to respective DPTOs under whose control the buses are being operated now as per new District setup.
2. To enter into amendment agreement as per Annexure enclosed on Rs.100/- non judicial stamp paper between the hire bus owner and the new DPTO for all the buses whose jurisdiction (erstwhile region setup to new district set up) has changed.
3. The existing agreements shall hold good till completion of existing validity for the hire buses whose jurisdiction (erstwhile region setup to new district set up) has not changed.
4. Henceforth, hire bus agreements if any (as per the tender condition / as per the instructions of HO) shall be entered by DPTO with hire bus owner, as per the present jurisdiction.
5. The agreements of the hire buses allotted from MSTC VI tenders onwards shall be entered into by DPTOs as per the new district jurisdiction of the respective depots.
6. At present DPTO/Paderu is in the cadre of JSO and no hire bus is under operation. As and when hire buses are pressed into operation at Paderu depot, separate instructions will be issued by nominating a DPTO to enter into agreements.

Necessary action shall be taken on the above lines and report compliance.

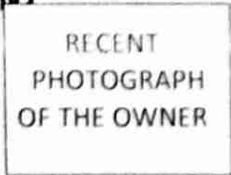

Vide Circular No PD-03/2022, dtd.19.04.2022, instructions were issued on Reorganization of Zonal and Regional set up in APSRTC on the lines of Govt. of A.P. orders and the existing offices of Regional Managers have been restructured into 26 District Public Transport Offices, which shall function co-terminus with the new districts formed by the state of A.P.

On Reorganization of District setup, the District Headquarters of 67 depots administrative control jurisdiction changed from erstwhile region to new district.

Hence, it is mutually agreed by the both parties for amendment of second party as DPTO of the respective District in place of Regional Manager of erstwhile Region in the existing hire bus agreement made on (Date of existing agreement) between the two parties and this amendment agreement is now being entered.

NOW THE AMENDMENT WITNESSETH AS UNDER.

1. The validity of this amendment is co-terminus with validity of main existing agreement.
2. The second party of agreement is now the DPTO of the respective district in which the bus is operated in place of Regional Manager of erstwhile setup.
3. All other Terms and Conditions of agreement shall remain unchanged.
