Sub: Operations – Payment of Double duty amount to Drivers & Conductors and operation of additional trips on payment of spot amount of Rs 2/- per kilometer to the crew booked for the operation of extra trips – Issue of instructions – Reg:

In view of heavy traffic demand during Sankranti festival season, vide reference 1<sup>st</sup> and 2<sup>nd</sup> cited instructions were issued to the field managers to engage Outsourced/ RTC retired drivers and to enhance the payment of Double Duty amount to the Drivers and Conductors per duty @ Rs 800/- & Rs 700/- respectively during the Sankranti holidays from 09.01.2020 to 21.01.2020.

Vide reference 3<sup>rd</sup> cited, instructions were issued to the Depot Managers to operate more Kilometers during the special occasions and peak hours duly paying the Rs 2/- per Kilometer on the spot to each conductor and Driver for operating extra trips.

APSRTC is operating 480 Badibassulu for transporting bus pass holders so as to ease the congestion in regular buses and to increase the revenues. These buses are being operated with regular drivers in spite of heavy shortage.

In view of heavy shortage of Drivers & Conductors, the competent authority has accorded approval:

- To continue to utilize outsourced/ RTC retired drivers on payment of Rs 800/- per duty.
- To continue the payment of double duty for driver @ Rs 800/- & for conductor @ Rs 700/-
- To utilize Outsourced / RTC retired drivers for operating badibassulu subject to handling the driver TIMs on payment of Rs. 600/- per duty.

Hence, the payment of enhanced double duty amount to the Drivers / Conductors and utilization of outsourced/ RTC retired drivers to operate schedule and special services shall be continued as per the payment details specified above until further orders.

Further, Badibassulu shall be operated with Outsourced/ RTC retired Driver on payment of Rs. 600/- per duty. The Outsourced/ RTC retired Driver shall be insisted to operate Badibassulu with TIMs.

Therefore, all Regional Managers are advised to issue suitable instructions to the field Managers to operate maximum volume duly following the above instructions. Instructions given on engaging Outsourced/ RTC retired drivers vide letter at reference 1<sup>st</sup> cited shall holds good.

IT department shall take up necessary software modifications to pay the amount on the spot to the conductor/Driver who performed extra trips.
