Sub : FARE REVISION – Revision of tariff of Silver cards, Vihari cards and Return Journey Tickets (in and around Thirupathi) consequent to fare revision from 24.10.2015 – Continuation of existing Tariff for Greater Visakha/ Krishna Veni GBT - Reg.

Consequent to the revision of ticket fares w.e.f.24.10.2015 vide reference first cited, the tariffs of Silver cards, Vihari cards and Return Journey Tickets (in and around Thirupathi) are also revised as furnished below.

3. Over stamping of existing stock :

The Depot Managers are advised to arrange to over stamp the existing stock with revised tariffs as mentioned above. The crew shall be instructed to allow the Silver card holders with old tariffs, who have purchased the Silver card prior to the fare revision.

All the terms and conditions remain unchanged.

4. Vihari cards :

Existing tariff of Vihari cards is Rs.550/-. Consequent to the fare revision w.e.f.24.10.2015, the tariff of Vihari card is revised as **Rs.600/-**. The existing Vihari card stock available in trays/with ATB agents and RTC Nesthams, at traffic section, etc., shall be over stamped as above.

All other terms and conditions remain unchanged.

5. Revised tariff of return journey tickets (in and around Thirupathi) :

Revised fares of various return journey tickets (in and around Thirupathi) are furnished below :
