Sub:HIRING - Hiring of private buses vide July 2014 tender notification – Imposition of penalties for delayed production of hire buses beyond allowed period of 90 days - Reg.

Ref: Circular no. 50/ 2013 – OPD (PLG), Dt. 05.11.2013

The corporation is meeting its requirement of fleet for operation of services by engaging buses under Hire Scheme through Public Tender Notification.

As per the conditions of July 2014 tender schedule and tender allotment letter, entrepreneurs have to produce the buses within 90 days from the date of allotment letter with prescribed bus body specifications.

V.C & M.D with the concurrence of FA&CAO authorized the Executive Directors of Zones to induct hire buses by collecting penalties as follows:

I. **JULY 2014 TENDER NOTIFICATION - Related production of hire buses beyond the permitted period of 90 days:**


In case the allottees of hire buses avail more days for production of hire buses than the permitted 90 days from the date of allotment letter, concerned Executive Director of Zone is competent to accept such hire buses by collecting following penalties from the owners of hire buses.

| S.no | Particulars | Penalties |
|------|---|-----------------------------|
| 1 | From the date of Route Allotment Letter to 90 days | No Penalty |
| 2 | Delay in production of the bus for First 15 days (i.e., from 91 st day to 105 th day) | @ Rs. 500/- per bus per day |
| 3 | Delay in production of the bus for over and above 105 th day (i.e., from 106 th day to 150 th day) | @ Rs. 600/- per bus per day |

- II. In case hire bus operators avail more time than 150 days from the date of route allotment letter, concerned Executive Director of Zone is competent to accept hire buses produced belatedly from 151 days to 365 days from the date of allotment letter, by imposing a consolidated penalty of Rs. 60,000/- per bus.
- III. In case of payment of penalty by hire bus owner for belated production of bus, the caution deposit paid by owner is refundable.
- IV. Details of the allottees who have not introduced their buses after availing more time than 150 days from the date of route allotment letter be notified to the Head Office.
- V. To issue notices to all the entrepreneurs who have failed to produce buses within 150 days from the date of route allotment letter to produce buses immediately duly ascertaining details of vehicle chassis, etc.

The above instructions will come into force immediately.
