Sub:- Fares – Passenger Cess : Revision of passenger cess being collected from the passengers travelling in all special type services and also from passengers travelling in Pallevelugu & Ultra Pallevelugu services – instructions communicated – Reg:

Instructions were issued vide letter under reference 3<sup>rd</sup> cited, to collect Rs. 2/- per passenger per journey in respect of adult and child passengers travelling in Express and Ultra Deluxe/ Deluxe services and Rs. 3/ in respect of adult and child passengers travelling in special type services viz Super Luxury, Indra, Garuda, Garuda Plus, Amaravathi and Vennela services w.e.f, 11.01.2016.

Vide Circular under reference 1<sup>st</sup> cited, Accounts department has issued detailed instructions to the units to credit the revenue realized on sale of passenger cess tickets under separate account head 0323 "Passenger Amenities Fund"

In view of substantial developmental activities being taken up at bus stations, the following instructions are issued on collection of revised passenger cess:

- To collect Passenger cess @ Rs. 5/- per passenger per journey in respect of Adult and child passengers travelling in all special type services viz, Express, Deluxe, Ultra Deluxe, Super Luxury, Super Luxury AC, Indra, Garuda, Garuda Plus, Amaravathi, Dolphin Cruise, Night Rider and Vennela.
- To collect Passenger cess @ Re. 1/- per passenger per journey in respect of adult and child passengers travelling in Pallevelugu and Ultra Pallevelugu services.

The details of existing and revised Passenger cess to be collected from adult and child passengers performing on each journey are given below:

No passenger CESS shall be collected from the passengers of City services.

These instructions will come in to force w.e.f., (14. 04. 2022). The Crew shall be advised not to collect difference of Passenger cess who reserved their seats prior to revision of passenger cess. The other instructions issued wrt., collection of passenger cess vide reference 2<sup>nd</sup> and 3<sup>rd</sup> cited are stands good.

Therefore, all Regional Managers and Unit Officers are hereby advised to issue necessary instructions to the operating crew duly endorsing the same in MTD 141 cards in respect of the above services.
