Sub:- VEHICLES – Inventory of Vehicles and seats as on mid-night of 31st March-2023 - Particulars called for – Reg.

The census of vehicles and seats as on mid-night of last day of the financial year is one of the important task to be compiled by the Depot-Manager, Works Manager, Dy.Chief Mechanical Engineer and Controller of Stores. Census data is used for assessing the profile of vehicles at respective units.

For the year 2023-24, the Depot Manager, Controller of Stores/Works Manager have to conduct a census of vehicles and seats as on mid-night of 31st March-2023 on the lines given hereunder.

In the past experience, it is noticed that there are variances in the information like seating capacity, date of commissioning, when compared to the previous year's Inventory statement.

Hence attention may be paid to avoid such sort of mistakes again while compiling the statement. To have uniform information, the Seating Capacity as recorded in RC Books should be invariably adopted.

For the guidance of the Depot-Managers, Works Managers, Dy. Chief Mech. Engineers and Controller of Stores the explanatory note and the proforma are appended here-under (copies enclosed).

1. **Format – "A"** : relates to vehicles held at Depot. This is to be prepared and submitted by the Depot along with Make and types of the Vehicle, Vehicle No and its Seating Capacity (Excluding Drivers & Conductors) both **for RTC and Hire Vehicles**, duly certified by Depot Manager. Changes made in seating capacity on conversion if any, may also be certified by RTA in the R.C Books and same Seating Capacity to be shown in Format- "A" by the Depot Manager.
2. **Format- "B"** : relates to the vehicles received and transferred during the year 2022-23. This shall be prepared and certified by the Depot Manager.

3. **Format – "C"** : relates to vehicles kept at Work Shops. This shall be certified by Works Manager.
4. **Format – "D"** : relates to the vehicles kept in the **Park-yard**. This shall be certified by Dy. Chief Mechanical Engineer(Scrap yard I/c) of the Zone concerned.
5. **Format –"E"** : relates to the vehicles disposed off by Stores during the year 2022-23. This shall be certified by the Controller of Stores of the Zone.
6. **Format – "F"** : This shall be prepared by MIS wing of the district for all Depots basing on the Inventory of vehicles received from the Depots and other units after cross checking with their monthly records. The certified copies of Format–F (of all Depots of the district) to be submitted i.e., **for RTC buses, Hire Buses and Total buses** to ATM(MIS)/RTC House, one copy to Zonal office and another copy to Dy. Chief Accounts Officer of the Zone by 15th of April, 2023.
7. **Format – "G"** : relates to Type-wise buses i.e., (1)Green Saptagiri (2)Green Intercity (3)Vennela-24 (4)Vennela-30 (5)Dolphin Cruise (6)Amaravati (7)Night Rider-48 (8)Night Rider-42 (9)Garuda (10)Metro Lux-AC (11)Indra (12)Star Liner (13)Super Luxury (14)Ultra Deluxe (15)Saptagiri Express (16)Express (17)Ultra Pallevelugu (18)Pallevelugu (19)Metro Express (20)City Ordinary etc., Total buses, Total seats, Total standees, Grand total and average carrying capacity of each type and unit total.
This shall be prepared by MIS wing of the district for all Depots. The certified copies of **Format–G** (of all Depots of the district) for **RTC buses, Hire Buses and Total Buses** to be submitted to ATM(MIS)/RTC House, one copy to Zonal office and another copy to Dy. Chief Accounts Officer of the Zone by 15th of April, 2023.
8. The Registration No. prefixed by AP01Z/AP02Z/AP03Z/AP28Z/AP29Z/AP39Z etc., shall be clearly indicated.
9. The type of vehicles viz.,(1)Green Saptagiri (2)Green Intercity (3)Vennela-24 (4)Vennela-30 (5)Dolphin Cruise (6)Amaravati (7)Night Rider-48 (8)Night Rider-42 (9)Garuda (10)Metro Lux-AC (11)Indra (12)Star Liner (13)Super Luxury (14)Ultra Deluxe (15)Saptagiri Express (16)Express (17)Ultra Pallevelugu (18)Pallevelugu (19)Metro Express (20)City Ordinary etc., / DGT/Water Tanker /Oil Tanker / Jeep (Diesel / Petrol) / Cars (Diesel / Petrol) etc. has to be furnished clearly.
10. Make of vehicles viz., Tata /Leyland /Volvo /Scania /Eicher /Isuzu /Benz etc., has to be clearly specified.
11. The seating capacity of the Bus has to be given clearly showing **the number of seats excluding that of Driver and Conductor** as per R.C. Book. Specify standees if any separately, in addition to the seating capacity for all City Buses.

12. Date of commission shall correspond to the one given in the log book.
13. KMs Operated by the vehicle since commission shall be identical with the figures given in the vehicle log book.
14. The number of complete overhauls as mentioned in the vehicle log book shall be furnished.
15. The location of the vehicles as on mid-night of 31-03-2023 has to be specified. For example whether the vehicle is at Depot/Night halt/Work shop/stabled/ in transit etc.

Note :

The Buses being stabled by 31-03-2023 on completion of 15 Yrs are not required as they will not be in operation from 01-04-2023.

Hence all DMs, WMs, Dy CME(I/c Scrap Yard), COS and DPTOs are requested to submit the above information as per given schedule.
