2. Over Stamping of existing Stock:

The Depot Managers are advised to arrange to over stamp the existing stock with revised tariffs **which is inclusive of Passenger Cess. The crew shall be instructed to allow the Silver Card holders with old tariffs, who have purchased the Silver Cards prior to the Fare Revision.** From 06.11.2013 onwards Silver Cards should not be sold on old tariffs under any circumstances.

3. Printing of Silver cards with revised tariffs.

Works Manager, printing press, Miyapur shall arrange to print the Silver Cards with revised tariffs in the next consignment.
